You are invited to provide input on your concerns and recommendations regarding special education services, exclusionary discipline practices, and implicit bias in the Sacramento City Unified School District. Your input will help us, and the district fulfill the requirements of the negotiated service agreement between Sacramento City Schools, plaintiff students and their representatives, and the Black Parallel School Board.

The experts team is providing their questions for the CAC to discuss and develop answers at their meeting, but do not intend to conduct an interview through same. While we may join the public Zoom meeting, our intent is to observe only, as opposed to directly engage in that forum.

Role of the Expert Team

The Expert Team is working in collaboration and coordination with one another to answer questions related to the following:

- **Special Education.** Dr. Jean Gonsier-Gerdin will conduct an in-depth, data-driven analysis of the Sacramento City Unified School District's ("District's") special education services and delivery system.
- **Implicit Bias.** Dr. Nancy Dome ("Dr. Dome") and Rozina Kapadia shall conduct an in-depth, data-driven analysis of whether implicit and structural bias exists in the District's special education services and delivery system and school discipline system, with additional focus on the effectiveness of the District's professional development curriculum regarding implicit bias. This analysis shall include gauging the cultural competence levels across the District and the degree to which subsequent implicit and structural biases exist.
- **School Discipline.** Dr. Jeffrey Sprague ("Dr. Sprague") shall conduct an in-depth, data-driven analysis of the District's school discipline system.

Questions

- What are your concerns or recommendations regarding exclusionary discipline practices in SCUSD (office referrals, out of class or out of school suspensions)?
- What are your concerns or recommendations about the processes for referral, assessment, eligibility for special education services and IEP development practices within SCUSD?
- What are your concerns or recommendations about the Implicit Bias training provided by The District?
- What are your concerns or recommendations about bullying and harassment in the District?
