**Recommendation:** To honor Earth Day and receive updates on how Sacramento City Unified School District (SCUSD) is mitigating and adapting to climate change through projects and programming focused on buildings and energy, restorative schoolyards, waste reduction, and transportation.

**Background/Rationale:** SCUSD schools are becoming healthier and more sustainable learning environments for students and staff due to the vision of our Board of Education and the hard work of countless employees, parents, students, and community partners. In honor of Earth Day, we will update the community on our efforts to decarbonize our buildings and make them more energy efficient, rethink our schoolyards to make them more climate resilient and better equipped for diverse forms of play, reduce waste and greenhouse gases through food waste diversion and food recovery, and electrify our buses and decrease barriers to active transportation.

### I. Overview/History of Department or Program:

Earth Day was created in 1970 in response to increasing air and water pollution created by unregulated industrialization. This led to the creation of the Environmental Protection Agency and new environmental regulations, but it was not an inclusive movement. This resulted in increased environmental benefits in more affluent, predominately white communities across the United States, which was often coupled with increased pollution and deregulation in less affluent communities predominantly consisting of higher percentages of Black, Indigenous, and other people of color (BIPOC).

As stated in its Vision Statement, Sacramento City Unified School District (SCUSD) vigilantly works to interrupt systemic inequities and level the playing field. This includes the facilities department where we use an equity index to reinvest capital dollars in historically marginalized communities and schools. All students deserve a healthy and supportive learning environment, and added attention must be given to communities harmed by historical inequities.

In 2011, SCUSD hired a full time Sustainability Manager to oversee Project Green, an education program that taught staff and students about resource conservation through environmental education. This evolved into participating schools applying for, or opting in to, sustainability projects, like rain gardens, on their campuses. The position of Sustainability Manager was vacant from 2020-2023 and Facilities used this time to update the job description to a more systems level, District-wide approach, to ensure that all students and staff are experiencing the benefits of increasingly efficient and healthy schools. This system's level work currently includes Energy and buildings, Resilient and restorative schoolyards, Waste reduction and food capture, and Energy and transportation.
