The enrollment process consists of a bunch of 'hurry up and wait' steps.

If you want your student to attend a school with a mandatory visitation, you have to do that before January. Then if it's TK you can't even enroll right away. Advice is to enroll at the local school site, meaning we're completing two sets of paperwork.

Paperwork can only be dropped off at the enrollment center, which is 30 minutes away from some school sites.

Then you don't know if you'll be selected for the before/after school programs (which you can only learn about by word of mouth, because enrollment information isn't available for those either).

Last year we found out the day before school started that kiddo was able to join the enrichment program. Meaning, we had already jumped through OTHER hoops trying to ensure we had care, just to find out that was a waste of our time.

Please do better. Connect your systems to each other, inform staff members and families how to use your systems, and set up systems that don't take 2-5 months to find out whether a family has access to the resources they need to send their student to school.
