I went to talk to the Vice Principal Mr. Gibbs and the Safety Officer Johnny they both stated that their responsibility stops that the sidewalk directly outside of the school parking lot facing Kiefer Blvd. They both stated the staffing deficiency is the reason why there is not any supervision for all student's afterschool that are catching the bus directly outside of the school. The first assault my daughter was at this bus stop outside the school where there are no adults to supervise the students to make sure that they get on the bus safely. The school's response to my concern is there is no staff and to go to the board meeting and let the district know my concerns about the lack of supervision. Here I am. The lack of supervision afterschool to ensure that not only does my daughter get on the bus safe but all students is appalling. As I picked up my daughter from school on 9/27/2023 at 3:30p there was a group 30 students jaywalking across Kiefer Blvd to the bus stop as I waited at the light, I began to see 2 students fighting in the middle of this group of students. I started honking my horn to hopefully get some attention, but the students continued to fight. I look around and again no adult in sight. I say all that to say this, the lack of supervision perpetuates bullying, physical harm, and an unsafe environment for my daughter and all the students at Rosemont High School.
