**Recommendation:** Approve Sutter Middle School Field Trip to Ashland, Oregon March 16-18, 2016

<u>Background/Rationale</u>: March 16-18, 2016, a group of 125 students, 27 parent chaperones, and two teacher chaperones from Sutter Middle School will travel via chartered bus to Ashland, Oregon, to see plays at the Oregon Shakespeare Festival. Students will experience acclaimed literature and professionally performed art, allowing them to study and enjoy Shakespeare's *Twelfth Night* and Charles Dickens' *Great Expectations*. Additionally, students will attend three workshops presented by members of the theater group, and attend prologue discussions. The students and chaperones will be housed in the dorms at Southern Oregon University.

<u>Financial Considerations</u>: No cost to the district. Expenses paid through parent contribution. Associated Student Body funds were made available for students in need.
