<u>Recommendation</u>: To conduct Public Hearing to consider the level of support for the renewal of the charter for St. Hope Public Schools: Sacramento Charter High School.

Background/Rationale: The Governing Board will hold a Public Hearing in accordance with Education Code section 47607 (b) to consider the level of support for the renewal of St. Hope Public Schools: Sacramento Charter High School (Charter petition expiration date: June 30, 2017). Sacramento City Unified School District received Sacramento Charter High School's charter renewal petition on September 26, 2016. SCUSD and St. Hope Public Schools have mutually agreed to waive the 30 day Public Hearing requirement as well as mutually agreeing to a 30-day extension for approval or denial of the charter renewal for Sacramento Charter High School.

Public Hearing on the Renewal of the Charter for St. Hope Public Schools: Sacramento Charter High School November 17, 2016



I. OVERVIEW / HISTORY

Sacramento City Unified School District originally granted St. Hope Public Schools: Sacramento Charter High Schools' charter petition for establishment on July 2003. The charter petition has been renewed twice and is now due to expire June 30, 2017.

Sacramento City Unified School District received a charter renewal petition from Sacramento Charter High School on September 26, 2016. Sacramento Charter High School is seeking a fiveyear renewal term for their proposed independent charter school for students in grade levels 9 - 12. The purpose of the Public Hearing is to consider the level of support for the renewal of the charter for Sacramento Charter High School.

II. DRIVING GOVERNANCE

The Charter Petition process is guided by Education Code 47605. The Governing Board will hold a Public Hearing in accordance with Education Code section 47605 (b) to consider the level of support for the Charter Petition for Sacramento Charter High School. Public Hearing must be held within 30 days of receiving a petition and Board Action must take place within 60 days of petition receipt unless both parties mutually agree to an extension of an additional 30 days.

A charter may be renewed an unlimited number of times; however, each renewal must be for exactly five years. (EC 47607). If a school district fails to make written factual findings to support a denial within 60 days of the district's receipt of a petition, the charter school's petition is automatically renewed. (Cal. Code Regs., tit. 5, §11966.4(c).)

Sacramento City Unified School District and St. Hope Public Schools have mutually agreed to waive the 30 day Public Hearing requirement as well as mutually agreeing to a 30-day extension for approval or denial of the charter renewal for Sacramento Charter High School. The 30-day extension is beneficial because it allows staff adequate time and latitude to review the charter renewal application, and it ensures compliance with deadlines while considering the set schedule of Board of Education meetings.

III. BUDGET

The budget for Sacramento Charter High School should be detailed within the charter renewal petition and appendices. District staff will present a review of the charter's financials and provide the Board with a review of the analysis and a recommendation for approval or denial at the Board Meeting on December 8, 2016.
