4.0 DEFINITIONS:

- 4.1 Collection and Deposit Report Form (ACC-F012) a form stating which account to post the deposit, a description of the deposit, and the amount(s). This form must be reviewed and signed by the principal.
- 4.2 Blue Bear SchoolBooks software Student Activities database
- 4.3 Unorganized student activity Unorganized student activities are allowed in elementary and high schools in which the student body is not organized. Student Activity fundraisers teaches students about real life business activities and provide money to fund student extra-curricular activities.

- 5.1.3 Verify form is signed by principal
- 5.1.4 Open Blue Bear SchoolBooks software program
- 5.1.5 Go to File, change school, select school
- 5.1.6 Highlight school
- 5.1.7 Hit Select
- 5.1.8 Go to entry, click bank deposit entry
- 5.1.9 Click # for new deposit number Do a bank entry for each bank receipt.
- 5.1.10 Type date of deposit. See bank receipt
- 5.1.11 Type amount of deposit
- 5.1.12 Enter
- 5.1.13 Type "STUDENT BODY" (using Caps)
- 5.1.14 Hit Tab
