



 - 1. General Notes: ADD note to read, "6. Patch concrete where anchors have been removed."
- C. Sheet A8.1.2, Details
 - 1. Detail 11, Kitchen Wall at column: ADD note to read, "Provide corner guards as shown: 2-inch x 2-inch x 16 gauge stainless steel, type 304, with #4 Satin finish, as manufactured by Koroseal Wall Protection Systems or accepted equal. Length to be 8'-0". Install to walls securely in accordance with manufacturer's written instructions."
 - 2. Detail 12, Kitchen Wall Column Section: REVISE "4" x 18 GA. studs" to read "3-4" x 18 GA. steel studs".
- D. Sheet S1.1.1, Repair Details
 - 1. Detail 12, Infill Existing Penetration at Slab or Wall.
 - a. DELETE detail in its entirety and REPLACE with drawing AD4.01 included with this addendum.

 - 1. Demolition Notes: REVISE Note 2 to read, "Remove existing floor receptacles including box and wiring. Abandon conduit below floor. Patch floor to match existing."
