#### Lease-Leaseback (Education Code § 17406) Project Delivery Services For Athletic Sports Complex at Luther Burbank High School A Joint Use Project Between the City of Sacramento and Sacramento City Unified School District and Athletic Fields at various schools within Sacramento City Unified School District

The City of Sacramento ("City") and Sacramento City Unified School District ("District") are seeking a qualified entity, whether as a single firm or an association of firms ("Entity" or "Entities"), to provide the following component services for comprehensive Lease-Leaseback ("LLB") Project Delivery Services during all phases including design, approval, preconstruction, and construction phases ("LLB Project Delivery Services"):

- (1) Architect/Engineering services;
- (2) Preconstruction Consultant services; and
- (3) Construction services.

Beals Alliance, Inc. has provided an overall master plan including the projects for which LLB Project Delivery Services are sought. They are:

(1) the City of Sacramento and Sacramento City Unified School District Joint Use Athletic Sports Complex Project at Luther Burbank High School ("Joint Use Complex Project"); and

(2) as yet unspecified Sacramento City Unified School District athletic field projects at various sites ("District Field Projects").

Whenever hereinafter referred to collectively, the Joint Use Complex Project and the District Field Projects will be called "the Projects."

This Request for Qualifications describes the projects, the selection process, and the minimum information that must be included in the proposal.

# I. INTRODUCTION

## Section 1.

The City and / or District, through this RFQ process, invite Entities to present proposals for LLB Project Delivery Services for the Joint Use Complex Project at Luther Burbank High School, a comprehensive high school located at 3500 Florin Road, Sacramento, California, 95823, and for District Field Projects. It is our belief that using the LLB construction project delivery method, and involving all project participants early in the process in a collaborative atmosphere of equals will result in a project that can be delivered with more predictable results: reasonable and reliable budgets, reliable timelines, and the best possible quality. We seek to gain the benefit of an environment where team members are encouraged to share ideas freely in an atmosphere of mutual respect, tolerance, and trust, and to explore ways to delivery method. Team members will be expected to work together to achieve transparent and cooperative exchange of information in all matters relating to the project, and to share ideas for continuously improving project delivery during the course of design and construction.

## Section 2.

It is the intent of this RFQ process, and the questionnaire and documents required herewith, to assist the City and / or District in determining responsibility prior to the submission of proposals and to assist in selecting qualified, responsible Entities. However, neither the fact of pre-qualification, nor any pre-qualification rating, will preclude us from determining whether an Entity has the quality, fitness, capacity, and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness, after it has already pre-qualified. Rejection of any or all proposals, to contract work with whomever and in whatever manner, to abandon work entirely, and/or to waive any informality in receiving of proposals is reserved as the right of the City and / or District. Before a contract is awarded, the City and / or District may require from the proposed Entity further evidence of the reasonable qualifications of such Entity to faithfully, capably, and reasonably perform such proposed work and may consider such evidence before making its decision on the award of such proposed work.

Each questionnaire must be signed under penalty of perjury as designated at the end of the form, by the individuals who have the legal authority to bind the Entity on whose behalf those persons are signing. Each Entity must complete a questionnaire. If any information provided becomes inaccurate, the Entity must immediately provide notification and updated accurate information in writing, under penalty of perjury.

Answers to all questions contained in the questionnaire, information about current bonding capacity, notarized statement from surety, and supplemental information, including a profit/loss statement for the current period, and an audited year-end fiscal report, are required. This information will be the basis of rating Entities. Entities that are comprised of an association of firms are required to have each such firm individually answer all such questions, and individually provide all such information, reports, and statements. The City and the District reserve the right to check other sources. The decision regarding qualification will be based on objective evaluation criteria.

# II. CRITICAL DATES

## Mandatory Pre-Submittal Conference

A Mandatory Pre-Submittal Conference will be held on Monday, April 27, 2009, at 1:00 PM starting at the following location: Luther Burbank High School, a comprehensive high school located at 3500 Florin Road, Sacramento, California, 95823. Attendees will meet in the Administration Building, Burbank Room. At the Pre-Submittal Conference, City and / or District representatives will distribute information and materials to further describe the Projects, the scope of work, and may walk up to the site of the proposed Joint Use Complex Project. Respondents shall consider and address the materials and information distributed at the Pre-Submittal Conference in their submittals. Entities that fail to attend the Mandatory Pre-Submittal Conference are ineligible to respond to this RFQ.

# III. The Projects/General Scope of Work

The District secured the services of Beals Alliance, Inc. to provide an overall conceptual master plan for the athletic sports complex at Luther Burbank High School and the athletic field renovations at other high school and middle school campuses.

The Joint Use Complex Project will require complete design for and demolition of existing field, structures and appurtenances and the construction of Synthetic track and field, bleachers and ancillary structures, ball fields, and completion of the complex including facilities for concessions, and tennis and volleyball courts.

The District Field Projects will require complete design work for the renovation of various high school and middle school athletic fields through DSA approval. Actual construction is contingent upon District financing.

## IV. Contract Parameters

## **Financing**

The City and / or District do not contemplate borrowing any funds from the selected Entity.

Funding for the Joint Use Complex Project is dependent upon approval of the MOU between the City and / or District and available funding. All lease payments and final payments will be made with City and / or District funds. Therefore, no additional fees for inclusion of a separate development or financing entity will be considered. All other projects, if awarded, will use District funding.

#### Compensation

Architectural/Engineering Services shall be compensated pursuant to the terms of the district's Architectural/Engineering Services Agreement.

Compensation for Preconstruction Services shall be included, as a separate line item, in the Guaranteed Maximum Price (GMP) set forth in Lease-Leaseback Documents to be entered into by the parties, and shall be payable pursuant to the terms of the Lease-Leaseback Documents. Construction Services, as a separate line item, shall also be included in the GMP. The Entity shall

assume the risk of cost overruns that were not foreseeable at the time the agreement is entered into. The GMP is a fee to the Entity and the Entity shall be entitled to any unused portions of it. The GMP shall include, but not be limited to, increases in labor and materials, and the Entity shall not be entitled to additional payments because of such cost increases.

The City and / or District reserve the right to review GMP for compliance with City and / or District proposed budget and may terminate Preconstruction Services at any time without cause.

## Contract Documents

If ultimately awarded a project, the Entity shall perform work subject to the terms and conditions of the following district contract documents: Architect/Engineer contract, a pre-construction contract, a lease-leaseback agreement, site lease, sublease, project stabilization agreement, and district's General Conditions for Contract of Construction, dated March 9, 2007 ("General Conditions").

## Special Conditions

- 1. <u>Non-Discrimination</u>. The District does not discriminate on the basis of race, color, national origin, religion, age, ancestry, medical condition, disability, or gender in consideration for an award of contract.
- 2. <u>Drug-Free Policy and Fingerprinting</u>. The selected LLB entity shall be required to complete any and all fingerprinting requirements and criminal background checks required by State law and shall also be required to complete a Drug-Free workplace certificate.
- 3. <u>Prevailing Wages</u>. Respondents are advised that these projects are a public work for purposes of the California Labor Code, which requires enforcement of prevailing wage requirements.
- 4. <u>Securities.</u> Respondents are advised that if awarded a contract they will be permitted, at their request and expense and in accordance with Section 22300 of the California Public Contract Code, to substitute securities equivalent to retention monies withheld by District to insure performance under the contract.
- 5. <u>Bonding.</u> The successful LLB Entity will be required to furnish a Performance Bond in the amount of one hundred percent of the contract price, and a Payment (Material and Labor) Bond in the amount of one hundred percent of the contract price.
- 6. <u>Limitation.</u> This RFQ does not commit the City or District to award a contract. Costs incurred with the preparation of an SOQ pursuant to this RFQ, are the sole responsibility of the Entities.

# V. Scope of Services/Relationships

## Project Definition

The District and Entity will establish the project quality, cost, and schedule. All are expected to fully participate and collaborate. The project definition (scope, budget, quality, and schedule) that results will be agreed upon by all, with the expectation of project delivery within the established parameters. For the Joint Use Complex Project, the City will participate and collaborate in the project.

## Design and document production

Various members of the Entity will be involved during various phases of design and document production at a level much greater than is typical in design-bid-build projects:

1. Schematic Design Development Phase will involve the procurement of design consultants selected based on qualifications and fee. The A/E firm shall submit

qualifications to the City and / or District for review and approval. A/E firms shall possess, or procure design consultants that possess Building Information Modeling (BIM) capabilities.

- 2. Design Development Phase will involve the procurement of subcontractors to provide design assistance to the Entity. The Entity will competitively bid subcontract work and submit bids to the City and / or District for review and approval.
- 3. 100% Construction Document Phase will involve the procurement of subcontractors to provide design assistance through DSA Project plan approval. In addition, the Entity will competitively bid subcontractor work and submit bids to the City and / or District for review and approval.
- 4. The City and District reserve the right to reject any and all subcontractors.
- 5. It is our further preference that the Preconstruction Services will involve the individuals and subcontractors who will actually construct the Projects.

## **Constructability**

The City and / or District believe that constructability review is a process, not an event. The Entity and its subcontractors will be expected to provide constructability input on a continuous basis, and will be involved throughout design, document production, and DSA review period.

# Self-performed Work

The City and / or District recognize that self-performed work may be a benefit to the projects and encourage the Entity to propose to self-perform trade scopes of work whenever it is in the best interest of the projects. The City and / or District will ultimately determine whether to accept such proposals, and retain the right to require any scope of work to be priced by at least two qualified subcontractors.

## VI. Statement of Qualifications Format and Content

The Statement of Qualifications (SOQ) should be clear, concise, complete, well organized and demonstrate the Entity's qualifications and ability to follow instructions.

Eight (8) bound copies and one (1) unbound copy of the SOQ shall be provided, with all materials bound to an approximately 8 ½" x 11" format. Please number pages.
