Kit Carson is now an IB school and has added grades 9 through 12, adding one grade at a time. Students must test prior to grades 11 and 12 in order to graduate with the IB certificate.

The Committee would like to know how many students attend Kit Carson and how many students come from Caleb Greenwood.

#### 6.0 Bond Fund Update

Amari Watkins and Crystal Hoff presented to the Committee the Bond Program Status Report – Period Ending October 31, 2017.

*Comment/Question: The CKM Core Academic Renovation budget was \$19m and now it is \$22m. Does this reflect the variation or the amount supplemented for the field?* 

Answer: The prior amount reflects the construction budget, which is vastly different than the overall project budget. It could be a 20 to 25% difference.

SCUSD is on target with bond sales and repayment schedules. The Committee would like to see the repayment schedule. Each sale has its own schedule. Staff will email the Committee the pertinent schedules/summaries.
