7.0 Bond Fund Update

Staff presented to the Committee the most current E-Builder Report dated May 31, 2018 and the Bond Program Status Report for period ending March 31, 2018.

The District is looking at a small bond sale in July 2018 near the amount of \$10m in order to keep consistency and to be able to fund forthcoming projects. The purpose of this sale is a strategic sale to leverage the dollars and not lose available authorization from the measures.

Question: What is left after the sale? Answer: \$118m

8.0 Projects/Staff Update

Staff presented to the Committee the most current project list.

Question: When will the project at West Campus begin? Answer: There are some delays at DSA but due to start June 18, 2018. Completion June 2019.

Question: How is the Central Kitchen project coming along? Answer: The Central Kitchen project is divided into 2 phases. The renovation of the existing warehouse to increase the capacity of the freezer/refrigerator along with adding another dock. This should be completed in March of 2019. Once this is completed, demolition of the existing Transportation facility will begin as well as the construction of the Central Kitchen.
