6:20pm – 6:34	Update on English Learners - R30 Census - Reclassification	Vanessa Girard, Director, Multilingual Literacy	<ul> <li>Vanessa showed slide showing SCUSD EL enrollment over time, noting that EL population has declined at a slightly higher rate than overall enrollment. Both have been on the decline for approximately 14 years. In 1996, ELs were 27% of SCUSD students. Today they are 22% of SCUSD students.</li> <li>Spanish continues to be the most common language spoken by ELs, followed by Hmong, Cantonese and Vietnamese; consequently there tend to be a greater number of services for Spanish speaking students. She gave examples of services, mostly translation. Also gave examples of how schools should be looking at the schools R-30.</li> </ul>
