BASIC FUNCTION:

Perform independent, specialized gang prevention and intervention activities with the assistance of the Sacramento City Police Department, Sacramento County Probation Department, Sacramento County Sheriff's Department, Sacramento City Unified School District's School Resource Officers (SRO), and community-based organizations; act as a gang prevention and intervention specialist; conduct work utilizing independent judgment and analysis.

Develop, plan, and conduct training sessions to school staff, parents, students, and administrators under the guidance of the Sacramento City Police Department and County Probation. E

Coordinate numerous activities conducted on K-12 campuses related to gang violence, gang prevention and intervention, counseling, and mentoring. **E**

Establish modified mentoring program for students participating in grants related to gang violence and prevention. ${\bf E}$

Communicate with family members of students who are inclined to demonstrate gang involvement. E

Conduct research on gangs to increase knowledge about effective gang prevention and intervention programs. E

Assist K-12 campuses to identify and reduce visibility of the gang element on campus by enforcing the dress code policy, prohibiting the writing of graffiti, the flashing of gang signs, and the use of gang names. **E**

Assess campus conditions related to gang activity through observations, interviews, and surveys. E

Identify and document the gang population in school and the community at large. E

Work with school improvement initiatives that close student achievement gaps between racial, ethnic, and economic groups by working with all of the diverse communities. **E**

Coordinate, compile, and prepare statistical data for reporting purposes; research and gather information utilizing the Internet; assist in ensuring compliance with grant reporting requirements, guidelines, rules, and regulations. **E**

Operate a computer to input, output, update, and access a variety of records and information; generate records, reports, queries, lists and summaries from computer database; operate standard office equipment. **E**

Provide gang awareness training to staff, parents, and community groups; conduct and attend meetings, workshops, and training related to gang prevention and intervention; drive a vehicle to conduct work; lift light objects. **E**
