## **Board Policy**

### **Naming Of Facility**

BP 7310

#### **Facilities**

The Governing Board shall name schools or individual buildings in recognition of:

1. Individuals, living or deceased, who have made outstanding contributions to the county or community
2. Individuals, living or deceased, who have made contributions of state, national or worldwide significance
3. The geographic area in which the school or building is located

The Board encourages community participation in the process of selecting names. A citizen advisory committee shall be appointed to review name suggestions and submit recommendations for the Board's consideration.

(cf. 1220 - Citizen Advisory Committees)

The renaming of existing schools or major facilities shall occur only under extraordinary circumstances and after thorough study.

#### **Memorials**

Upon request, the Board shall consider naming buildings, parts of buildings or athletic fields in honor of the contributions of students, staff members and community members who have been deceased for at least one year.

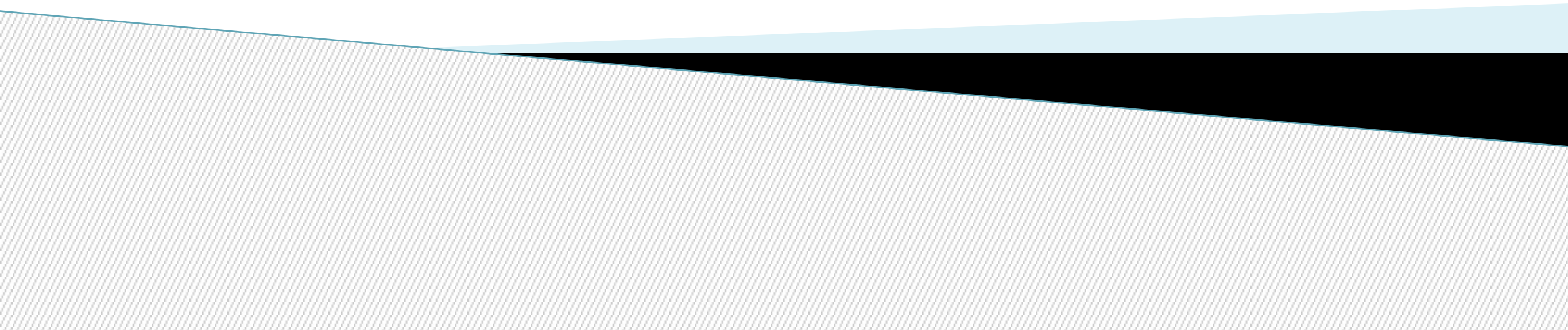




# 2012-2013 Daily Schedule

- School will be **shorter 1 day** out of the week (by about 1.5 hours)



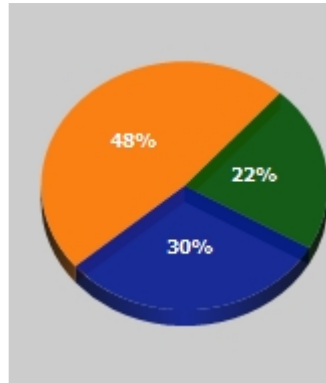

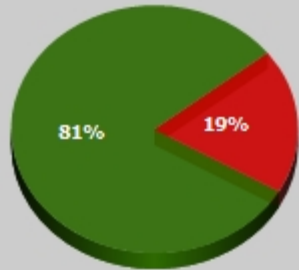

#### Renaming Proposal:

- **Rationale-** to make school relative and relevant to our students and families.
- **Redesign implications-** Part of priority school design process. Aligned with district/school initiatives.
- **Relevance-** Jed Smith is not relative to the lives/perspectives of our families and students.
- **Proposal of names-** group forward two names:
  1. **Leataata Floyd "Tata" Elementary**
  2. **Marina Grove Elementary (combination of the names of the two neighborhoods where students live).**

#### Discussion

- **Mr. Moody (community member)** "expressed heart felt sentiments in favor of name change."
- **Mr. Brim (former community member, former SCUSD student);** "agreed with Mr. Moody. Shared that he grew up in New Helvetia (Alder Grove) and was directly supported by Tata."

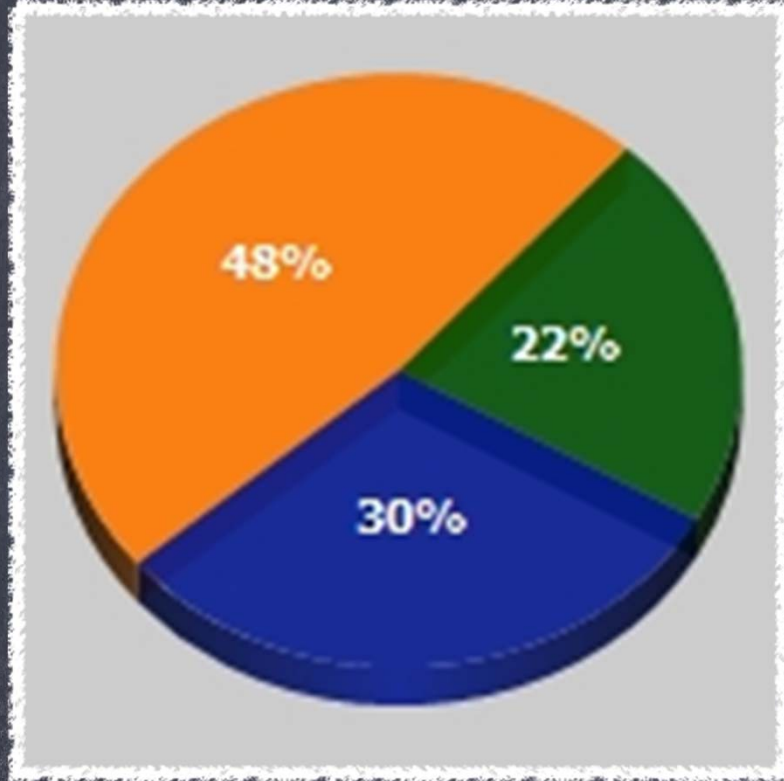

- Review Process of Renaming a Facility

- Gather Feedback
  - Dr. Hazel Mahone felt the process was equitable and the community was asking for Jedediah Smith Elementary School to be renamed.
    - Mike Brim reiterated.
    - Jennifer Garcia reiterated.
  - More discussion from staff than is reflected. Jennifer Garcia will provide additional information. Derrell Roberts will provide additional information.
  - SEIU Union would have no concerns about changing the name. The union would be inclined to go along with what the community wants.
  - SCTA Union Representative believes there would be no concerns about changing name to reflect recommendation by teachers at Jedediah Smith Elementary School.
  - Take out “tata” and keep it formal – unanimous.
- Proposal of Names
  - Leataata Floyd Elementary School
  - Marine Grove Elementary School –
    - Marine Grove ES was an add-on for compliance and is not reflective of what community recommends.
