



California lub tus thawj uas yuav hloov tsev kawm ntawv kev siv nyiaj txiag rau cov tub ntxhais kawm ntawv ntawm lub xeev uas feem coob muaj cov menyuam tsis muaj niamtxiv, tau nyiaj hli tsawg thiab cov uas nyuam qhuav xyam kawm lus meskas. Nrog rau lub Local Control Funding Formula, lub xeev no thiaj li cia rau cov koog tsev kawm ntawv los muss iv cov nyiaj txiag kom yooj yim rau cov tub ntxhais kawm ntawv no sib pauv kom ntawv dua nrog cov koog tsev kawm ntawv kev tswj nyiaj txiag.

Nyob hauv qab LCFF, koog tsev kawm tau txais:

- **LCFF Base Funding** -Nyiaj yog los mus pab rau cov tub ntxhais kawm ntawv rau ib lub xyoos. 

Vim li no cov koog tsev kawm ntawv SCUSD thiaj li faib cov nyiaj pab Supplemental thiab Concentration no rau cov tsev kawm ntawv.

Yog lawm uas koog tsev kawm ntawv thiaj li muab qhov kev tswj no rau tus thaj khu loj, cov xib fwb, neeg ua dejnum, cov niamtxiv thiab cov tub ntxhais kawm ntawv kom siv cov nyiaj no raws li lub tsev kawm seb yam twg tsis muaj es thiaj tau yuav los rau.
