Pov thawj qhia tau tias kev sib raug zoo thiab kev xav xws li paub txog kev sib raug zoo thiab kev ntseeg tus kheej muaj kev sib cuam tshuam rau kev vam meej ntau dua nyob rau hauv tsev kawm ntawv thiab lub neej thiab qhia tau zoo dua uas cov qhabnee xeem ntawv uas keev muaj tas los qhia tsis tau. Txoj kab li kev cai zoo thiab kev nyab xeeb ntawm ib lub tsev kawm ntawv uas muaj cov kev xav uas yuav tsum muaj qhia meej thiab cuag ncuaj kuj yog ib qho uas tseem ceeb. Ib tug tub/ntxhais qhov kev xav tias nws nyob muaj chaw thiab muaj kev nyab xeeb ntawm tsev kawm ntawv yuav ua tau rau nws txoj kev kawm loj hlob tuaj.

Cov results uas tau los ntawm daim ntawv ntsuam xyuas yuav raug muab siv los ntawm Hauv Paus Tsev Kawm Ntawv coj los txhawb kev sib raug zoo & kev xav kom loj hlob thiab ntxiv kev ruaj khov rau pib txoj kab li kev cai zoo ntawm tsev kawm ntawv thiab kev nyab xeeb los ntawm Kev Pab Kom Coj Cooj Pwm Zoo thiab Kev Txhawb (Positive Behavioral Interventions and Supports (PBIS)).

Txhua lub tsev kawm ntawv uas muaj txog 70% ntawm cov tub/ntxhais kawm ntawv uas koom rau qhov kev ntsuam xyuas yuav tau txais \$1,000 nyiaj mus rau kev txhim kho tub/nxhais kawm ntawv kev kawm tau ntawv.
