Contest Guidelines

Submission requirements

- Students from schools signed up to participate in the Green Week event 2017 are eligible to provide submissions for the poster contest.
- One submission per student.
- Poster size should be a minimum size of 8.5" x 11" or letter size. Card stock paper preferred.
- All entries must be original work, hand drawn or computer generated. Do not use copyrighted or trademarked images or contents
- Group or team entries are not allowed.
- Complete the 'Contest Form' with student's name, age, grade, participating school and teacher's name, parent /guardian name and consent signature. The contest form will be distributed by Sacramento City Unified School District (SCUSD)
- SCUSD will collect the posters from participating schools which will be provided to City of Sacramento Department of Utilities.
- Entries will not be returned or acknowledged, and upon submission become property of City of Sacramento Department of Utilities.
- All contestants submitting an entry (and their parents/legal guardians) hereby agree and consent, without further authorization, compensation or remuneration of any kind, to the use of their name and/or likeness and their entry in any and all advertising, promotions and other publicity conducted by City of Sacramento Department of Utilities, except where prohibited by law.
- City of Sacramento Department of Utilities will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive

- City of Sacramento Department of Utilities will not knowingly disclose personal information about contestants without prior parental or legal guardian consent, except as required by law.
 - Limitations of Liability: By entering the contest, each contestant and their parents/legal guardians agree that: (1) all disputes, claims, and causes of action arising in connection with the Contest, or any prizes awarded, shall be resolved individually without resort to any form of class action, and contestant waives his or her right to a jury trial for such disputes, claims, and causes of action; (2) any claims, judgments and awards shall be

entries for any reason. Any questions regarding the number of entries submitted shall be determined by DOU staff in its sole discretion, and DOU reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Contest.

<u>Judging</u>

- A contest selection committee comprised of staff from The City of Sacramento Department of Utilities and Regional Water Authority will review all entries received.
- Entries will be judged for creativity, aesthetic appearance and spirit of their display.
- Entries will be divided into 3 categories Grades K-5, Grades 6-8 and Grades 9-12.
- After initial review, the contest selection committee will select twelve (12) posters, 4 from each category as finalists for social media voting on DOU Facebook Page by October 17th, 2017.

Voting

- Winners will be selected by public voting on DOU Facebook Page. The public voting period will run from Oct 17th 2017 to October 27th, 2017.
- Voters can cast votes for one poster in each category. Voters are not required to like the Department of Utilities Facebook Page to participate. The contest is in no way sponsored, endorsed or administered by, or associated with, Facebook. Any information provided through voting will only be used for this contest's purposes.
- Winners from each category will be announced on October 31st, 2017.
- City of Sacramento Department of Utilities reserves the right to reject any entry determined in its sole discretion not to be appropriate for viewing by the public.

Prizes

- First prize winner from each category will win \$500 classroom grant for the teacher and trophy/certificate for the winning students.
- The second and third prize winners in each category will receive \$200 classroom grant for the teacher and trophy/certificate for the winning students.
- Prizes will be awarded to winners or winner's teachers at an event agreed upon by City and SCUSD.
- No substitution, cash equivalent or transfer of prizes permitted.
