1.0 OPEN SESSION / CALL TO ORDER / ROLL CALL

The meeting was called to order at 4:32 p.m. by President Pritchett, and roll was taken.

9.0 BOARD WORKSHOP/STRATEGIC PLAN AND OTHER INITIATIVES

9.1 College and Career Readiness Update (Christina Espinosa and Linda Kingston)

Information

Director of College and Career Readiness Christina Espinosa Director of Career Readiness/Master Scheduling Linda Kingston, and Linked Learning Coordinator Daniel Spinka presented. They gave a summary of college and career readiness and went over a career technical education data snapshot, linked learning alliance partnership, equity gaps addressed by linked learning, the linked learning approach and experience, K-12 continuum for college and career readiness, current District investments, and work so far.

President Pritchett thanked the team. She asked what happens if a student is not doing well with a particular teacher. Ms. Kingston answered that this is where intervention services enter that work together.

Vice President Garcia asked about expansion. Ms. Espinosa spoke about different data variables and identifying support.

Member Murawski expressed her support for linked learning.

Member Villa thanked the presenters for their work and commented that this is important for students, as not all students learn the same.

9.2 Approve Addendum to Superintendent Employment Agreement to Remove California Consumer Price Index (Christina Pritchett)

President Pritchett reported that this Board item has come about due to Superintendent Aguilar's request at the last Board meeting. He has asked for an addendum to his contract which will eliminate any potential adjustment to his salary based on the Consumer Price Index.

President Pritchett and Board members Villa, Woo, and Murawski all thanked the Superintendent and gave their support. President Pritchett motioned to approve the item, and Member Woo seconded. The motion passed unanimously 7-0.

First Reading

10.1 Public Hearing: Proposed Fiscal Year 2022-2023 Budget for All Funds (Rose Ramos)

This was heard second as a Public Hearing item. Assistant Superintendent of Business Services Adrian Vargas, Director of Accounting Jesse Castillo, and Budget Supervisor Gabe Estrada presented. The team went over financial reporting requirements, May revise highlights, 2021-22 estimated actuals, the 2022-23 proposed budget, 2022-23 multi-year projections, and potential future risks and opportunities.

Member Phillips asked if the District is taking advice from any outside groups that have reviewed the District budget.

Mr. Vargas replied that the District is using School Services as a dartboard to make the assumptions that were built into the budget. He also said the biggest one was a \$47 million dollar liability noted by the District's independent auditor. Most advice is being given by School Services, CSBA, and CASBO, and most are using the same assumptions to build the budget. Member Phillips asked if there are recommendations by other groups such as the Black Parallel School Board. Mr. Vargas replied that community input is provided through the school site plans. Superintendent Aguilar added that the Community Priority Coalition did submit input.

Member Villa thanked the presenters. She spoke about exploring the option of working with Wide Open Walls starting with the upcoming school year. She would like \$2,000 per year to be budgeted so that one school per year can participate.

Member Murawski thanked the presenters. She commented that it is an exciting year and that there is a lot going on in terms of making the best use of the one-time funds available. She supports Member Phillips in requesting more explanation of what is in the budget. She also said she would like to see two—three days of professional development built into the budget as a long-term goal, more mental health supports for students, and one-time funds used for new social science textbooks. In an effort to stem declining enrollment, she would like to see a community based marketing plan.

Vice President Garcia supports the request to simplify communicating investments to the community. She asked about Special Education expenditures, specifically noting a projected increases of \$4 million dollars in 2022-23, \$8 million in 2023-24, and another \$8 million in 2024-25. Mr. Vargas said a trending 6.5 percent increase was added. She supports Member Villa's request for Wide Open Walls, and also would like to see expenditures on staff for students' mental health and field trips for middle and high school students. She requested one additional fte per site and said that this year the District will receive historic funding from the state that will give an opportunity to stabilize the budget and spend in these areas. She asked for the meaning of material revisions presented within 45 days of the state enacted budget. Mr. Vargas explained that material revisions means a big change in revenue which is significant, and he gave examples.

President Pritchett asked the Superintendent to check with staff to see if the requested expenditures have already been incorporated. She agrees with Vice President Garcia regarding the need to have more social workers at sites, and she noted that there are several positions currently open that have not been filled.

Superintendent Aguilar asked the Board to think of the LCAP presentation as an extension of this presentation.

Second Vice President Rhodes motioned to extend the meeting to 12:30 a.m. Member Murawski seconded, and the motion passed 6-1 with Member Phillips voting no.

10.2 Public Hearing: SCUSD SELPA Local Plan – Contacts, Annual Budget Plan, Annual Service Plan (Christine Baeta, Sadie Hedegard, and Geovanni Linares)

This was heard fourth as a Public Hearing item. Director of Special Education Local Plan Area (SELPA) and Assistant Superintendent of Business Services Adrian Vargas presented. They went over the District's SELPA Local Plan annual budget and service plan, transparency to the Local Plan, and next steps.

Member Murawski thanked the presenters. She proposed to move the adoption of the plan with the caveat that there be a brief annual report by the first Board meeting of the next school year that lays out the chief performance indicators that are being tracked on a management level with respect to students with disabilities and the services the District is providing, as well as key initiatives that are being implemented over the course of the coming year.

Vice President Garcia asked if the maintenance of effort means that the District has to spend as much as was spent the prior year. Mr. Linares explained that although there are students that graduate out, there are always new students coming in that require services.

Member Murawski moved adoption of the plan along with the addition of a report that lays out key performance indicators and key initiatives that will be undertaken in the coming year to address improvement of those key performance indicators, and that report would be provided on or before August 31st of 2022. Member Woo seconded, and the motion passed unanimously.

10.3 Public Hearing: 2022-23 Local Control and Accountability Plan (Steven Ramirez-Fong)

Action

LCAP/PAC Coordinator Steven Ramirez-Fong presented. He summarized the overall budget landscape for the 2022-23 Local Control and Accountability Plan (LCAP), provided an overview by goal of the 2022-23 LCAP actions, projected expenditures, and metrics, shared recent updates to the LCAP since the May 5th presentation, and gave a recap of next steps.

Second Vice President Rhodes said he appreciates the detailed connection of the LCAP to District spending.

Member Woo motioned to approve, and Member Villa seconded. The motion was approved unanimously.

10.4 Approval of the Project Labor Agreement (Rose Ramos and Nathaniel Browning)

This was heard first as a Public Hearing item. Director of Capital Projects, Facilities and Resource Management Nathaniel Browning presented. He described project labor agreements (PLA), and went over PLAs and the District, 2017 revisions to the PLA, newly proposed revisions, and goals and next steps.

President Pritchett thanked staff who have been working with District partners. She appreciates commitment from all trades and help with the CTE program.

Vice President Garcia thanked staff for their commitment and dedication in coming to a partnership.

Member Woo thanked all for what is done for students.

Second Vice President Rhodes said he is happy to move this item forward for approval.

Member Phillips commented on Mr. Terrence Gladney's public comment concerning the use of the term "red line". She also noted that an article was included that does not allow for strikes. Mr. Browning said the initial intent behind a PLA is to outline a process for arbitration in order to get through sticky situations so that strikes do not occur or lockout workers.

Member Woo seconded Second Vice President Rhode's motion to approve. The item was approved 6-1 with Member Phillips abstaining.

11.3 Superintendent's Report (Jorge A. Aguilar)
