One of my kids goes to Cesar Chavez and while our Principal is great, we need more resources and more bilingual programs. The Assistant Superintendent for our school has done nothing for our kids or our families. She just comes to see the Principal but I have not seen in her in over a year. Meanwhile I have kids at schools where Dr. Simms and Dr. Mackey work or supervise, and I have seen those 2 ladies on the campuses, talking with the Principal and walking classrooms as recently as 2 weeks ago. I don't know why you all would decide to let these ladies go because I know they could not and did not have anything negative related to their job performance otherwise Dr. Mackey's name would not be on the agenda tonight as a resignation. Either way, something is not right. Its also not right that you all were super happy about a plan for the new funds but did not include a thorough plan for improving english learner instruction or increase bilingual programs.
