Comment:	I'm commenting regarding the impasse with SEIU. My dad is a retired teacher, and when I started teaching, he gave me some advice: always be nice to the office manager, the plant manager, and the custodians, because they keep the whole school running smoothly. I've now been teaching for two decades, and it's true. They, along with the campus monitors, nutrition services workers, attendance clerks and other classified staff represented by SEIU are the backbone of any school campus.
	I looked at the salary schedules this morning. The highest a campus monitor or instructional aide can possibly earn is a little over \$3200 a month. The highest a health aide can earn is a little over \$4000 a month. The highest a custodian can make is just over \$3000 a month. The highest a nutrition tech can make is less than \$3000 a month.
	The average rent in Sacramento is about \$1500 a month, and average child care can cost \$11k a year.
	So how on earth can we expect SEIU folks with kids whose kids, like the rest of ours, will be returning, if at all, only two days a week to suddenly come up with 10 weeks of child care on a moment's notice?
	The district needs to go BACK to the bargaining table with SEIU and work with them on their reasonable requests, which include things like allowing workers with child care needs to continue working from home.
	These workers are essential to our campuses' safety, success, and smooth operations.  Take my dad's advice, and be nice to them.

Comment:	Our valued classified staff members deserve the same treatment in terms of the ability to bring their children to school during the concurrent teaching situation as that being given to teachers. Even those classified staff members at the highest end of their pay scale make less than half what teachers with similar seniority receive. We cannot expect them to suddenly find and afford childcare with such short notice. Some have students continuing distance learning who will need supervision when not in their classrooms. To only allow classroom aides to bring their children to school is just wrong.
	Also - the constant back-and-forth over hazard pay is disrespectful and unfair. The district has been given millions in COVID funds, and fair compensation for those who have been putting their own health at risk for months now is a MUST.
	Finally, I am absolutely astonished that the district thinks that classified staff only need a 3 foot distance between themselves and students when certificated staff are allowed a 6 foot barrier. This is just another example of not giving our paraprofessionals the respect they so greatly deserve.

	4. How many students will the CENTER program accommodate compared to 4th "R" at each location?
