Proposed Tentative Agreement

Sacramento City Unified School District

&

Sacramento City Teachers Association

October 13, 2021

The Sacramento City Unified School District ("District") and the Sacramento City Teachers Association ("SCTA"), collectively referred to as "the Parties," have considered their mutual interests and have agreed to enter into this Tentative Agreement ("Agreement") to completely resolve negotiations for the 2019-2020 and 2020-2021 school years.

- 1. The Parties agree that the 2016-2019 collective bargaining agreement between the parties will be extended through and including June 30, 2021 with no changes to the existing collective bargaining agreement provisions.
- 2. This Agreement will conclude and completely resolve all negotiations for the 2019-2020 and 2020-2021 school years.
- 3. The District proposes a new three-year collective bargaining agreement term (2021-2022, 2022-2023, and 2023-2024) as described in the District's response to SCTA's proposal on Article 26 dated October 13, 2021. The District's proposals for successor contract negotiations are a package consisting of the articles listed in the "Status of District Proposals" document attached hereto.
- 4. The Tentative Agreement shall become effective upon ratification by SCTA, AB 1200 County Office Approval, and approval by the Board of Education of the District, as evidenced by the signature of the SCTA and District designees and by ratification of the SCTA unit members and by formal Board action of the District Board of Education.
