Good evening Members of the Board,

I am Nikki Milevsky, 1st Vice President of SCTA.

Recently, for bargaining, we received a list from the district of all of the current SCTA Certificated Vacancies as of November 19th, 2021. Please see first attachment with 40.5 classroom vacancies and 85.7 vacancies that the district is calling non-classroom (RSP; Elementary PE, Spanish and Technology; School Psychologist, etc.)

Please look at the second attachment which is the certificated layoffs you approved on February 18th of 2021. You can easily compare the credentials for which you laid off teachers and the credential areas for which you still have vacancies even in November of this school year. This means that thousands of students have not had credentialed teachers for the first 3 months of this school year in the very same credential areas that you laid off teachers.

The third attachment is the email plus documentation of the damage to students from the layoffs of 2020 and the subsequent vacancies in the 2020-21 school that I sent you on February 17, 2021.

The fourth attachment is the email plus documentation of the damage to students from the layoffs of 2019 and the subsequent vacancies in the 2019-20 school that I also sent you before the board meeting on February 18, 2021.

Prior to Jorge Aguilar's tenure as our superintendent, there had not been certificated layoffs since the Spring of 2015 when less than 20 teachers were laid off mostly from the conversion of part-day contract, single-session parent participation preschool programs to all double-session parent participation preschool programs.

We would appreciate your examination of this data and thoughtful approach to any suggestion of layoffs this year.

Please let us know if you have any questions. We would be happy to discuss this with you directly.

Dear Board Members,

Before you vote on the large number of layoffs the superintendent is asking you to approve Thursday night, we implore you to look at the facts of what happened as a result of the layoffs last year.

The first attachment is the layoff resolution from March 2020. Although this year's proposed layoff is even larger, you will see some similarities to positions that the board approved to layoff last year. As you can see last year, the board voted to layoff math, English, science, physical education, social science, art, elementary multiple subjects, k-8, special ed and other teaching positions.

Please look through the second and third attachments which are the postings of vacant positions the district needed to fill during the summer and fall of this school year. You will see the district trying to hire math, English, science, physical education, social science, art, elementary multiple subjects, k-8, special ed and other teaching positions that your staff told the board to layoff last March. Even after the school year started, the district still needed to hire teachers in many of these areas. This left many of our students without fully credentialed teachers for large parts of the year.

This year your staff is asking you to approve laying off 132 teachers in mostly the same areas the district mistakenly laid off last year. There is a national teacher shortage. Other districts, are out there recruiting diverse and fully credentialed teachers for their students. Please do not repeat the same devastating mistake again this year by voting to approve these unnecessary and destructive layoffs. Our students deserve to have fully credentialed teachers. Your staff needs to focus on recruiting and retaining them.

Please look at the layoffs that were approved by the board and compare them with the vacant positions the district needed to fill in the 2019-20 school year.

The first attachment is the certificated layoff resolutions from March 2019. The next 4 attachments are the vacancy posting for the summer and fall of 2019.

Please note that vacancies are only posted for hiring like this after all of the teachers who had been laid off with that credential have already been asked to return to work for SCUSD.

Just like the data I sent you regarding the results of the 2020 layoffs, you can see the district laid off critical, hard-to-fill credential positions like math, English, science, physical education, social science, Spanish, art, elementary multiple subjects, and others and then spent the summer and fall and even into the winter trying to find credentialed teachers for students throughout our district.

These layoffs have devastating impact on our students learning. Please stop this cycle of unnecessary and damaging layoffs recommended by the superintendent and his team.
