LEGAL ASSISTANCE

Legal Consultations to screen for remedies in a person's immigration situation or for individuals detained by Immigration & Customs Enforcement. Legal Representation for individuals in deportation proceeding, challenging immigration detention, and seeking bond. Legal Representation in affirmative applications for immigration status.

MENTAL HEALTH SERVICES

Individual and Group Therapy Sessions offered, specifically for but not limited to immigrant, refugee, and undocumented families.
