2022-23 School Overview

The school is nestled in the quiet neighborhood of the College Greens and Glenbrook areas of Sacramento, Bancroft Elementary School offers classes for early kindergarten (pre-K) and kindergarten through sixth grade students. We have a large, beautiful campus with flower gardens, park areas with picnic tables, over 80 trees, and three large playground structures.

Our vision is that "At Bancroft, students are productive, respectful citizens who have skills, knowledge, and continuously reflect on improvement". Our vision drives on what how we want our student to gain through their years at the school. We accomplish this by providing instruction in Common Core Standards in all curricular areas. Our instructional practices include hands-on activities that add excitement to the learning process, building upon each child's background knowledge and to foster inquiry about their learning. Beyond the basics, Bancroft Elementary offers opportunities for children to develop lifelong skills through a variety of activities and programs. This includes a full physical education program, a working computer lab, and an exemplary library. We also have four mobile computer labs for use in classrooms. Bancroft has a Schoolyard Habitat that works as an outdoor classroom to educate our students on plants native to California. The City of Sacramento provides their "4th R" before and after-school childcare program, in addition to the after-school ASES education and enrichment program on our campus. In addition, the school is also a Project Lead the Way school, in which we incorporate Science Technology, Engineering and Mathematics (STEM). The arts also play a major role in our overall school environment, including art docents to teach art lesson and the annual talent show.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college and career, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers. To that end, the district has crafted a high quality professional learning program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Mathematics, Science, Physical Education and Visual and Performing Arts. Since the onset of Distance Learning in the Spring of 2020, we have provided all teachers and administrators with professional learning on Universal Design for Learning, and the professional learning we have made available is geared to distance learning. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our Local Control Accountability Plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design. Professional learning opportunities are offered during school hours and outside of contracted hours. In addition to on-site coaching and regular professional learning opportunities, a designated collaborative Thursday time provides the opportunity for teachers to engage in collaborative professional learning at their respective schools focusing on deepening their content knowledge, strengthening their instructional repertoire, improving their assessment strategies, and fostering a shared sense of responsibility.

School Facility Conditions and Planned Improvements

Hubert Bancroft Elementary School, built in 1964, received Facility Inspection Tool (FIT) overall repair rating score of “good” from its most recent facility inspection in June 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district’s 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district’s wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements.
