Thank you for submitting a bid to the District for the C.K. McClatchy HS Baseball/Softball Field Improvements Project.

The District is pleased to inform you that it intends to award the contract to Robert A. Bothman Construction based on your firm being the apparent low bidder due to the bid protest result of D.L. Falk's bid being non-responsive.

The District intends to ratify the award for Construction (total base bid plus Bid Alternates 1 and 2) in the amount of **\$8,755,000** at the anticipated Board of Education meeting for approval recommendation on February 15, 2024. At this time, we request that you begin preparing and forwarding all required submittals for the project in order to expedite start of construction (See General Conditions Section 00 72 13, ARTICLE 10 – CONTRACTORS SUBMITTALS AND SCHEDULES).

In the event a contract is not awarded, reasonable costs for submittal preparation will be reimbursed.

Your date to start construction activities and completion date will be indicated in the Notice to Proceed.
