## AD 2.12:

Question: Please clarify when working hours can take place
Answer: The work site is available during non-school hours. Work hours may be, for example, 4pm-12am M-F and most weekends

AD 2.13:
Question: There is a Mural in the Gym with existing cabling to be demo'd going across it that is painted to fit the mural. Who is responsible for painting the stripe left by removing the cable across the mural?


## Answer:

The contractor should clip the wire where loose from the wall and leave it attached to the wall where the mural is.

## AD 2.14:

Question: All exposed conduit observed on the jobwalk was EMT. Please confirm the conduit type requirements for all areas.

Answer: Typically we match whatever surface runway is available. If it's EMT then stay with that.

## AD 2.15:

Question: The Iran Contra form is mentioned in bid documents but there is no form. Can you please supply?

Answer: This project does not have Iran Contracting Act certification requirements.
