Recommendation: Approve Annual Organizational Meeting for December 13, 2018.

Background/Rationale: Pursuant to Ed. Code 35143, the Board is required to set an annual organizational meeting “within a 15-day period that commences with the date upon which a governing board member elected at that election takes office. Organizational meetings in years in which no such regular election for governing Board members is conducted shall be held during the same 15-day period on the calendar”.

That 15-day period for 2018 is December 7 - 22, 2018. The day and time of the annual meeting are to be selected by the Board at its regular meeting held on November 15, which is immediately prior to the first day of such 15-day period, and the Board of Education shall notify the County Superintendent of Schools of the day and time selected.

The organizational meeting of the Board is scheduled to be approved for **Thursday, December 13, 2018 at 6:00 p.m.**, or as soon thereafter as the matter may be heard.
