All students deserve this resource. Has quite a few community partners.

Member Cochran on slide 14 there is a social emotional learning part of the diagram indicating that if an adult is bullying even if it is adult to student, it goes to HR? Jessica responds, accurate. Member Cochran continues asks President Ryan to call for a look at our policies to look at what our policy on employee bullying, employee to employee but also bullying from an adult to student. Would like this to be applied from the Board of Education all the way down to the one or two-hour employee at that school site. We start with a policy then maybe training. President Ryan given the hate rhetoric and the national unfortunate statement of division that we continue to see from our President and how that trickles down on every level asks Jessica to speak to the increased rate of bullying at the school site level. 11.3 Superintendent's Report (Jorge A. Aguilar)

Wants to first start by thanking Facilities team, under Cathy Allen, for all of the work that they put in for almost two years to finally reach a point to upgrade equipment in the Board room. The equipment we had was almost 20-years old. In addition we received information from Metro Cable that the video quality was not appropriate anymore. Fortunately, we did have some Capital Improvement Funds that we were able to use to make the upgrades. Wants to thank everyone involved in the many fall festivals that took place over the past week or so. We are now at the midway point of our flag football games. There's a lot of excitement and smiling faces. Wants to highlight a few of the top scores. In the Lion's League, Hollywood Park is in first place with a perfect 5-0 record followed by Crocker/Riverside, Oak Ridge and Sutterville. In the Cougar's League, Genevieve Didion is in first place also with a perfect 5-0 record followed by John Sloat, Matsuyama and John Bidwell. In the Warrior's League #1, in first place is Ethel I. Baker with a perfect 5-0 followed closely by Elder Creek. In Warrior's League #2, Caleb Greenwood and Phoebe Hearst are both 5-0 tied for first place. These two teams are scheduled to play each other November 7th at Kit Carson. In the Wolverine's League Golden Empire is in first place with 5-0, followed by James Marshall and Sequoia. In the Titan's League Parkway is in first with 4-0 with a tie and slightly ahead of Rosa Parks. Thank you to all staff, coaches, players, City of Sacramento Partners for making this flag football season a great success. Latest count showed 1200 elementary students are

now playing in the league and proudly wearing their jerseys during the school day. Would also like to thank the two senior students who came to speak during the Board meeting. we don't often get to hear from students. Pleased to hear from Mr. Harris about the progress we are making in terms of graduation and A-G requirements. We have a long ways to go. The results in our SBAC scores are not where we need them to be for our students. Wants to thank our African American Task Force members who have been here every single Tuesday evening and are actively working to present recommendations to our Board. Wants to close by reiterating that we must continue working together. We must continue to collaborate in order to overcome the immediate budget challenges that we face. Believes wholeheartedly that we will get through this budget challenge and move on to the important work which is keeping students at the core and at the center of what we do every day in Sacramento City Unified.

11.4 President's Report (Jessie Ryan)

Clearly we have been as a nation grappling with tremendous acts of hate and the implications on our children who are listening and watching as we grieve. Speaking specifically to the tragedy at Tree of Life Synagogue and the ripples that have been felt across the country and by our children as we know that hate rhetoric, that racism, that anti-Semitism and misogyny is reaching a level that is unlike anything that many of us have seen at least in our lifetimes. Would also like to say as we mourn the tragedy of Tree of Life, we also are in very short order having to deal with rhetoric at a national level about ending birth right citizenship in direct violation of the 14th Amendment. I think everyone here knows that we are proud leader of a Safe Haven School District. Being a Safe Haven School District meant that our schools are welcome to all irrespective of their race, their religious identification, their gender identification. We have to do everything we can to recommit to being a Safe Haven and to sharing the vital role that each and every one of our children play whether they are born here or not.

A couple of quick student group updates. The Men's and Women's Leadership Academy is producing a pod cast called the We Dream Pod Cast. It's available on iTunes, Apple Pod Cast, Anchor and You Tube. Feel free to give it a listen. The Source Media Agency is still looking to partner with ASBs and Student Governments at SCUSD high schools for the Be Here Campaign which is designed to decrease chronic absenteeism. The Student Advisory Council took yesterday off for Halloween, met previous Wednesday and continued the process of coding responses to the surveys to find out the issues students in our district are facing. Received two comments about looking into electronic text books for school sites. just thought to put that out there. Clearly something students are looking into.

As we been spending all this time talking about budgets and all kinds of other things that seem so far removed from the kids attending all these events was a nice reminder of why we are here.
