
All students are given an equal opportunity to graduate with the greatest number of postsecondary choices from the widest array of options

My Core Belief: We accomplish the above by redesigning systems to allow for greater focus on kids and learning

## What is an Authorizer?

- Charter Schools are **authorized** by a district or county to operate with some degree of independence from the district
- Authorizers are tasked with overseeing that their charters are operating within the the law.
- SCUSD authorizes 16 charter schools
  - **Dependent**: Closer relationship with authorizer
  - **Independent:** More removed relationship with authorizer



## Assembly Bill (AB) 1505

- Signed in 2019, Implemented in 2020
- AB 1505 focuses on...
  - The Importance of Local Control
  - o Clarity and Transparency
  - o Accountability, Use of Data
- The final version of AB 1505 included compromises for all groups
  - Stronger oversight for local authorizers
  - o Clear procedural and appeal rights for schools

Note: Though AB 1505 was in effect during COVID-19, the suspension of the state dashboard system and 2-year charter term extension meant limited implementation



# **Key Changes Under AB 1505**

#### **Renewal Criteria, Timeline, Appeal**

- Three-Tiered Criteria for Renewal
  - Criteria based on student outcomes reported on the CA Dashboard
  - Fiscal or governance concerns
  - o Not serving all students who wish to attend
- Timeline: 60-days to first hearing, 90-days, in total, to decision
- Appeal Rights
  - Appeal to County BOE if Authorizing district does not follow law or meet timelines
  - Appeal to State Board of Education if denied by County

#### **Other Changes**

- Removes Credential Flexibility
  - By July 2025, all teachers must hold appropriate credentials
- Charter Schools must operate within the authorizer boundaries
- Changes to considerations for new charter schools
  - Including community impact

## **Development** of SCUSD **Board Policies**

- Starting draft of policies based on CSBA (California School Board Association) model policies
- Engagement with stakeholders
  - o Legal Counsel
  - o Charter School Leaders
  - SCUSD School District Staff
- Comparison with surrounding districts and counties
