Highlights Since Last Time

- Mix of work progressing (some data collection, IM committees, equity walks, collaboration) and work waiting on condition setting (some data collection, district committees, self assessments, etc.)
- Success: MOU with SCTA for equity walks can serve as example (equity walks to continue, starting in ~2 weeks)
- More Lessons about Communications
- Challenge of Process vs. Time Current discussion between district and plaintiffs
 re: priorities given reality an academic year and impact on action plan
 - Looking to next year, negotiations need to be completed before summer

Highlights Since Last Time - Equity Walks

- \square 12/30 complete (4 may require redo); 2^{nd} rounds slated to begin in April
- ☐ Given 4 standards (cultural a. blindness, b. pre-competence, c. competence, d. proficiency), absence of data led to an assumed baseline of cultural blindness)
- □ While analysis would be pre-mature, initial meaning making with committee trend between cultural blindness and cultural pre-competence with outliers)
- To triangulate data will look alongside student achievement and experience data, school self-assessment data and in relation to efforts being made as part of portfolio

Black Parallel School Board: an authentic success

Potential of Equity Walks... one example and what made it impactful

- □ Well Balanced: represented by community, school, and district
- □ School Staff Prepared and Welcoming: collaborative, transparent/ honest communication and interaction with team; access to engage with students
- Walked the Talk: observed school model what they shared data real-time moment/serious incident addressed... in the moment and through de-escalation and support
- Why Important: gives not only staff but also community opportunity to view classroom and school experience through eyes of students experience it like the students do

Black Parallel School Board: What families need from the BOE

- ☐ In a district known for independence across and within sites, establish the work of the action plan as a core expectation for all
- Continue to reinforce partnership over adversarial perspectives not only for the parties, but for all members (i.e., bargaining units)
- Commit to the Action Plan's success and working to address and remove barriers inherent in the current culture and system
- ☐ When there is misunderstanding of the Action Plan, ask the authors their intent
- Individual site and leader commitments is critical support in directing commitments from all sites/ administrators to understand and own, connect and implement the action plan every day
- ☐ Given Action Plan's Vastness commit and systematize publishing regular progress (not just completion) updates and support opportunities to all families and school sites
