	A CBS News article from December 20th, 2023 states that the SCUSD board of education is considering discontinuing the multi-school CIF agreement. I am a student at the Met Sacramento and a Varsity Volleyball player for McClatchy. The fact that 7,700\$ and competition against worse teams are the main concerns that we it is irrefutably more harmful than anything else. It decreases the enrollment of students in charter schools, which are already underfunded and can't have intermural sports because we don't have money for equipment. I spent a year playing sports at the Met Sacramento High School before I became too good to enjoy the low-level volleyball that occurs amongst our small schools. The reason that the intermural leagues aren't as competitive is that we don't have as much funding. The article by CBS News on the board's meeting describes one of the problems being that 7,700 dollars is being spent on 2% of students from small charter schools who are taking advantage of the district's opportunity. How much of that money has been spent on the sports programs at small schools? More students may come to the Met and other small schools if we had money to advertise and create viable, competitive sports teams.
