School Description

Theodore Judah Elementary has been a neighborhood tradition since 1937. On the registry of historic places, this neighborhood school values each student as an individual and welcomes parent involvement. The school supports student academic achievement in all in all core content areas (i.e. English Language Arts, Math, Social Studies, Science, Physical Education) through a rigorous curriculum based on the Common Core State Standards, which is taught by experienced teachers.

By incorporating teaching techniques and strategies designed to engage all students and to promote life long learning, all students are held to high standards, and GATE services are available in grades 2-6. Staff monitors student academic progress during collaborative planning time and academic conferences. This data is used to focus staff professional development, and to provide data to support instructional planning during teacher collaboration sessions. Staff also uses this data to inform supplemental academic student support services, as needed. All students have access to the library and computer lab on a weekly basis. To support proper school readiness and for our youngest learners, Theodore Judah provides Early Kindergarten. This class provides a strong academic and social foundation for kindergarten success.

Our community believes in educating the whole child, and through our strong partnership with our Parent Teacher Association (PTA), we offer weekly instruction in Art, and Music for all students. Students are also further enriched through our instructional Garden and Science Alive program, which is complementary to our standards-based science instruction. Students engage in leadership opportunities by participating in our Green Team, and they lead the way in teaching others about recycling, waste reduction and environmental stewardship. We also have a wide variety of after school programs (e.g. speech and debate, Robotics) to extend and enrich the learning day. Social Emotional learning is supported throughout the day through the use of our 4B's: Be Safe, Be Respectful, Be Responsible, Be Kind. We also celebrate a monthly positive character trait.

About the SARC

The SARC contains information about the condition and performance of each California public school. School Facility Conditions and Planned Improvements (Most Recent Year)

The main campus was built in 1937. This school has 15 permanent classrooms which include a multipurpose room, a library, and an administrative building. The school also has 12 portables. 3 portables classrooms were constructed in 1997 for class size reduction. During the 2000 modernization, renovations and upgrades were made in the following areas: health and safety, HVAC, and miscellaneous upgrades.

The district takes great efforts to ensure that all schools are clean, safe, and functional. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. The district governing board has adopted cleaning standards for all the schools in the district. A summary of these standards is available at the school office, or at the district operations office. The principal works directly with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

The State Legislature established the Deferred Maintenance Fund (DMF) in 1980 to assist districts in maintaining facilities and sites. The District has participated in the Deferred Maintenance Program since its inception. The program requires both the local district and the State of California to share equally in the cost of major deferred maintenance projects, with the maximum contribution from the State limited to approximately one-half of one percent of the District's General Fund and Adult Education Fund operating budgets. For fiscal years 2008-09 through 2012-13, the Deferred Maintenance Program has been included in the State's Tier III Flexibility Program. Therefore, DMF funds received by the District are deposited in the General Fund, and are unrestricted. Due to state budget cuts for 2010-11 these unrestricted funds have not been designated to deferred maintenance purposes. The funds were used as part of the Tier III recommendations approved by the Board on the May 6, 2010 Board Meeting.
