Our school is a place of curiosity, enthusiasm, and safety where students can learn in a caring, dynamic environment.

About Our School

Nestled in the Rosemont Community, Golden Empire is one of the “best kept secrets” amongst Sacramento schools. The school has built its reputation on excellence in learning through parent and community involvement and highly experienced and skilled teachers and staff. Golden Empire Elementary achieved a growth score of 847 on the 2013 Academic Performance Index (API) and a CDE achievement rating of 10 out of 10 for like schools. We are proud of our school-wide awards. We were awarded the California Businesses for Education Excellence Award for years 2012--2017. In 2008, Golden Empire was selected as a United States Blue Ribbon Award School, 1 of 35 schools selected in the state of California, 1 of 2 schools in Sacramento County. We were again selected for this award for 2010. We were also selected as 1 of 13 schools in the nation for the prestigious 2009 National Center for Urban School Transformation’s Excellence in Education award. The school was also granted the “California Distinguished School Award” in 2008 and the “Title I Achieving School” award by the California State Department of Education in 2004, 2007, 2008, 2009, and again in 2010. Named an “Exemplary School” by the Sacramento City Unified School District, Golden Empire is proud of its many schoolwide academic awards and accomplishments.

The educational program at Golden Empire stresses incremental learning, collaborative learning, practice time for skill development, interventions for students needing academic review, and extended day for identified students. We have fully implemented The Leader In Me Social-Emotional Learning program, focusing on developing all students as leaders. Our GATE cluster program provides increased academic rigor and pacing to our high achieving and GATE students. Added-value curriculum includes PE, Library, and Computer Media Center programs, featuring the iReady diagnostic program focusing on California Common Core Standards. Our band program teaches 4th-6th grade students instrumental music taught by a credentialed music teacher. Our OSEP (On-Site Enrichment Program) provides after-school enrichment programs for students in grades 2-6. We are proud of our 4H Garden Club, composed of students in grades 2-6, who maintain our school garden and earn badges and pins for completing science and gardening projects. A credentialed teacher coordinates the Running Club and basketball tournaments. Also, we are extremely proud of our preschool program, serving 25 three- and four- year old students.

Our active Parent Teacher Organization (PTO) provides assemblies, parent nights, fun and successful community fundraisers, a carnival and numerous evening programs which encourage student and parent involvement. There are other opportunities for parent involvement, especially in the School Site Council (SSC) and our English Language Advisory Committee (ELAC).

Our 4th R and ASES programs offer on-site day care for busy families. Students have vision, hearing, and dental checks during the year.

An outstanding website (goldenempire.scusd.edu), weekly emails and a monthly family newsletter keep everyone up-to-date on school activities. Students receive attendance, good citizen, and honor roll awards each trimester at our Awards Ceremonies.

Golden Empire offers students a “Golden Opportunity” for achievement, and a safe, nurturing, and accepting environment for all. Come soar with us at Golden Empire Elementary!

School Facility Conditions and Planned Improvements (Most Recent Year)

The main campus was built in 1977. This school has 12 permanent classrooms which include a multipurpose room, a library, and an administrative building. The school also has 17 portables. 3 portables classrooms were constructed in 1998 for class size reduction. During the 2006-07 modernizations, renovations and upgrades were made in the following areas: health and safety, site exterior and miscellaneous upgrades.

The district takes great efforts to ensure that all schools are clean, safe, and functional. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. The district governing board has adopted cleaning standards for all the schools in the district. A summary of these standards is available at the school office, or at the district operations office. The principal works directly with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

The State Legislature established the Deferred Maintenance Fund (DMF) in 1980 to assist districts in maintaining facilities and sites. The District has participated in the Deferred Maintenance Program since its inception. The program requires both the local district and the State of California to share equally in the cost of major deferred maintenance projects, with the maximum contribution from the State limited to approximately one-half of one percent of the District's General Fund and Adult Education Fund operating budgets. For fiscal years 2008-09 through 2012-13, the Deferred Maintenance Program has been included in the State's Tier III Flexibility Program. Therefore, DMF funds received by the District are deposited in the General Fund, and are unrestricted. Due to state budget cuts for 2010-11 these unrestricted funds have not been designated to deferred maintenance purposes. The funds were used as part of the Tier III recommendations approved by the Board on the May 6, 2010 Board Meeting.

Professional Development provided for Teachers

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college career and life, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers.

To that end, the district has crafted a high quality professional program that is focused on the ELA and math Common Core State Standards, the Next Generation Science Standards, English Language Learners, Balanced Literacy and Instructional Strategies for Addressing the Needs of Diverse Learners. These areas of focus were derived from needs assessments coupled with the analysis of student learning of specific content and that is ongoing with follow-up opportunities, models effective practices, and uses assessments to guide and monitor progress. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our strategic plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design.

These learning experiences, which are offered during the school day and after-school are supported with on-site coaching, are complemented with the required collaborative time built into the school day on Thursdays, which is designated for teachers to engage in collaborative professional learning at their respective school sites. Such communities of practices, under the leadership and guidance of site administrators, afford our teachers the opportunity to deepen their content knowledge, strengthen their instructional repertoire, improve their assessment strategies, and foster a shared sense of responsibility. As a result, every teacher will help to promote and nurture a community of learners in which the individual school staff is not only enriched, but the district as a whole is enhanced.
