### School Description

Caroline Wenzel School is a caring community of students, parents, and staff dedicated to educational excellence. Staff, parents, and students have worked to make Wenzel a place where students feel safe, where their voice is heard (Student Council, Peer Mediators), where they are recognized for citizenship, attendance, life skills and academic efforts and most of all a place to have FUN while learning! The culture and climate of Wenzel are built upon a frame of ethical leadership focused on the standards of commitment, duty, equity, integrity, ethical responsibility, and respect.

Support services for continuous improvement in student achievement are provided to students. Class size is 24:1 in Kindergarten; 24:1 in 1st, 2nd and 3rd grades and 33:1 in grades 4-6. In addition to the regular K-6 classrooms, Wenzel has four special day classes for communicatively disabled students, a class for severely developmentally disabled students and an autistic transition class designed to transition autistic students into general education classes, as well as 18 full inclusion students and over 80 speech students, including students from private schools. Our special day classes are fully included in all school-wide events and programs. English Language Learners (ELL) program is available for qualified students in both an integrated and designated approach and is provided a number of opportunities throughout the day to have their curricular needs met. Caroline Wenzel provides a strong PE prep program. Caroline Wenzel is proud to also have a staffed library where students can check out books on a rotating basis. To add to our expanding services is a family resource support center, providing a variety of support to our school and families, including but not limited to mentoring and counseling. For the past two years, including this school year, Caroline Wenzel holds Saturday Academy to provide enriching learning opportunities for students. For the 2018-19 school year, Caroline Wenzel staff will engage in improvement science work as a method to bring improvement to teaching and learning.

Parents and community volunteers are a very strong resource and help to implement the overall school program in cooperation with an active School Site Council and the English Learner Advisory Council. Wenzel's dynamic PTO supports many important programs including a Peer Mediator Program for Conflict Management, and annual events such as an Intermediate Physical Fitness Meet, and a Primary and Intermediate Play Days. Parents have been instrumental in implementing family events such as our Spaghetti Dinner, Carnival, Family Science Night and Movie Nights as well as ancillary activities like primary and intermediate school dances. There is our new Caroline Wenzel Academy of Scholars (CWAS) licensed childcare program available for before and after school childcare on our campus in addition to the After School Education and Safety (ASES) after school program serving nearly 86 students in grades 1st - 6th. Finally, we have an active student council that meets once a week with the principal to discuss school-wide student issues as well as plan student activities. This year, leadership opportunities provided students with opportunities to serve as technology team, school tour teams, and mentoring team.

Parents, students, staff, and members of our community are all working together to continue Wenzel's path to continuous improvement in academics as well as having fun learning in an inclusive, caring, and small community environment!

**School Facility Conditions and Planned Improvements (Most Recent Year)**

Caroline Wenzel Elementary School, built in 1967, received Facility Inspection Tool (FIT) overall repair rating score of “exemplary” from its most recent facility inspection in June 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district’s 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district’s wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

## Professional Development provided for Teachers

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college and career, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers.

To that end, the district has crafted a high quality professional program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Differentiation of Instruction, Data Inquiry, Culturally and Linguistically Teaching and Learning, and Conceptual Understanding of Mathematics. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our strategic plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design.

Professional learning opportunities are offered during school hours and outside of contracted hours. In addition to on-site coaching and regular professional learning opportunities, a designated collaborative Thursday time provides the opportunity for teachers to engage in collaborative professional learning at their respective schools focusing on deepening their content knowledge, strengthening their instructional repertoire, improving their assessment strategies, and fostering a shared sense of responsibility.
