## 2021-22 School Overview

Camellia Basic Elementary School is an academic prep school that develops excellence through emphasis on a strong foundation in mastering academic standards and good behavior. The Camellia Basic School community, staff, parents and students work as a team to build excellence in both academics and citizenship. Camellia offers two programs to meet the needs of our families: Basic and GATE Cluster. A major emphasis of the Basic School Program in grades 1-6 is the development of academic skills and good study habits. Students must meet admission criteria to be accepted to the lottery for the Basic Program. The overall goal of the school staff is to bring together the most successful traditional and new methods of instruction which emphasize academic skills and good study habits. Parental support at home contributes to children's success in this rigorous program. A collaborative relationship between parents and teachers creates ideal conditions for student learning and high levels of achievement.

Gifted and Talented Education (GATE) supports excellence through a program that specifically addresses the needs of gifted children. The program at Camellia combines GATE instructional strategies and curriculum with our Basic program. This instructional model provides basic skills instruction, enrichment, acceleration and in-depth learning experiences for the more academically able student. The goal of our staff is to provide engaging instruction with rigor and relevance to make our students prepared academically and socially for the challenges of tomorrow. Students develop lifelong skills by participating in art, music, physical education and the sciences. Camellia's school-wide class meeting model helps students become outstanding citizens learning ethics, problem solving strategies, communication skills, and conflict resolution.

The staff at Camellia Basic believes that cooperation between the home and school is essential to the success of students in our programs. To promote understanding and commitment to the goals of the program, a 3-way contract between the parent, student and teacher is implemented in grades 1st through 6th. The contract outlines important expectations for students, parents and staff.

When enrolling students in our Basic or GATE program, parents are encouraged to volunteer 40 hours of their time towards their student's education. Parents may help in many ways such as assisting in their child's classroom, helping during family fundraising events by our PTSO, making copies weekly for the teachers, and assisting in the office as needed.

Camellia Basic has a tradition of excellence.

In May 1997, Camellia was recognized as a "Magnet School of Merit" by the Magnet Schools of America Association. Only 42

schools nationwide were awarded this honor.

In 1999, 2003, 2006, 2007 and 2008 Camellia was recognized as an “Achieving School” by the Sacramento City Unified School District.

In 2000, 2001, and 2002 Camellia Basic was named an “Exemplary School” by the Sacramento City Unified School District. It is the highest honor a school can achieve from the SCUSD Board of Education.

In 2002, 2006, 2018, 2020 Camellia Basic was recognized as a California Distinguished School. This honor is the highest recognition given by the California Board of Education.

In 2003, 2004, 2005, 2006, 2007, and 2008 California State Superintendent Jack O’Connell recognized Camellia Basic as a California Achieving School. This honor recognizes the highest performing schools in the state that receive Title 1 funding.

In 2003 and 2004, U. S. Secretary of Education Ron Payne recognized Camellia Basic as a National Achieving School. Only two schools in the state were recognized with this honor. This award recognizes the highest performing Title I schools in the state of California.

In 2003 and again in 2010 the U. S. Department of Education recognized Camellia Basic as a National Blue Ribbon School. In 2010 Camellia was one of only 21 schools in California to receive the honor.

## 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college and career, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers. To that end, the district has crafted a high quality professional learning program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Mathematics, Science, Physical Education and Visual and Performing Arts. Since the onset of Distance Learning in the Spring of 2020, we have provided all teachers and administrators with professional learning on Universal Design for Learning, and the professional learning we have made available is geared to distance learning. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our Local Control Accountability Plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design. Professional learning opportunities are offered during school hours and outside of contracted hours. In addition to on-site coaching and regular professional learning opportunities, a designated collaborative Thursday time provides the opportunity for teachers to engage in collaborative professional learning at their respective schools focusing on deepening their content knowledge, strengthening their instructional repertoire, improving their assessment strategies, and fostering a shared sense of responsibility.

## School Facility Conditions and Planned Improvements

Camellia Basic Elementary School, built in 1961, received Facility Inspection Tool (FIT) overall repair rating score of "good" from its most recent facility inspection in June 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district's 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district's wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-2021 school year to other school years.
