

### 2021-22 School Overview

The Oak Ridge staff is committed to building a community of well-rounded, confident, critical thinkers who are intrinsically motivated and empowered with a passion for learning. Students with positive character who are prepared to collaboratively work with others for high levels of success and happiness in life's path.

We continue to have our school goals reflect our mission in an effort to better meet the learning needs of our students. Our school is focused on the following six school-wide goals:

- 1. To decrease our overall chronic absenteeism rate by the end of 2021-2022 school year to 17%. Our monthly ADA goal will be at 94%.
- 2. Increase ELA foundational reading skills proficiency for students in grades K-2 will increase from 23% to 50% (site testing). Students on track in comprehension in grades 3rd-6th will increase from 26% to 40%
- 3. Using classroom math assessments, students who are on track will increase from 39% to 50%
- 4. By May 2022, English Learners who are comprehending grade level text as measured by STAR Reading Assessment will increase from 26% to 35%.
- 5. Using an anti-racist framework for school climate, Oak Ridge will examine school culture and climate through a critical evaluation of five pedagogical stances: language matters, history matters, justice matters, race matters, futures matter to guide our work towards a campus that is culturally responsive and creates an authentic sense of belonging for all students.
- 6. Support, engage and empower families and community as authentic partners within our school community.

Our overall approach stresses challenging and refining our belief systems, creating a healthy academic climate, and providing engaging instruction. We believe this will help all students thrive academically. We encourage students to build a strong sense of community with a Humanity approach that is rooted in Anti-Racism and Transformative Justice.

Something genuinely special and unique about Oak Ridge is the support we get from our community partners. We appreciate the strong bonds that have been formed with Soil Born Farms, Orrick Law Firm, City of Refuge and others. Our Partnerships work closely with the school to ensure that every student receives a quality learning experience.

We recognize that, above all, our single most important partnership is the one we foster with each of our families. Parents,

### 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college and career, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers. To that end, the district has crafted a high quality professional learning program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Mathematics, Science, Physical Education and Visual and Performing Arts. Since the onset of Distance Learning in the Spring of 2020, we have provided all teachers and administrators with professional learning on Universal Design for Learning, and the professional learning we have made available is geared to distance learning. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our Local Control Accountability Plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design. Professional learning opportunities are offered during school hours and outside of contracted hours. In addition to on-site coaching and regular professional learning opportunities, a designated collaborative Thursday time provides the opportunity for teachers to engage in collaborative professional learning at their respective schools focusing on deepening their content knowledge, strengthening their instructional repertoire, improving their assessment strategies, and fostering a shared sense of responsibility.

### **School Facility Conditions and Planned Improvements**

Oak Ridge Elementary School, built in 1962, received Facility Inspection Tool (FIT) overall repair rating score of "good" from its most recent facility inspection in September 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district's 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district's wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

#### **Statewide Assessments**

#### SARC Reporting in the 2020-2021 School Year Only

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### **Options**

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

The percentage of students who have successfully completed courses that satisfy the requirements for entrance to the University of California and the California State University, or career technical education sequences or programs of study.

### Percentage of Students Meeting or Exceeding the State Standard on CAASPP

This table displays CAASPP test results in ELA and mathematics for all students grades three through eight and grade eleven taking and completing a state-administered assessment.

The 2019-2020 data cells with N/A values indicate that the 2019-2020 data are not available due to the COVID-19 pandemic and resulting summative test suspension. The Executive Order N-30-20 was issued which waived the assessment, accountability, and reporting requirements for the 2019-2020 school year.

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-2021 school year to other school years.
