Woodbine Elementary School strives to provide a well-rounded education that is academically rigorous and engaging in a supportive learning environment. We are fortunate to have a skilled and dedicated staff who deliver high-quality instruction to our students. It is our goal to create a safe, supportive, and nurturing school environment by teaching the whole child where everyone is valued. Woodbine is supported by a community of caring families who engage in their child's education and are valued as our students' first teachers.

Woodbine Elementary maintains high expectations of all staff and students to ensure that all students being college, career, and life ready . Through rigorous, high-quality teaching practices of the Common Core Standards, Woodbine provides targeted English-Language Arts and Math instruction to meet all students' needs. All Woodbine teachers are committed to enriching instructional practices through collaboration and professional development by partnering with the Sacramento County Office of Education (SCOE). Woodbine staff also have been provided training and instructional materials to teach SIPPS (Systematic Instruction in Phonological Awareness, Phonics, and Sight Words), a research based phonics program to ensure all Woodbine students are fluent readers. Additionally, Woodbine has implemented school-wide PBIS (Positive Behavioral Interventions and Supports) to improve social, emotional, and academic outcomes for all students. We promote successful social-emotional behavior through proactive strategies and a systematic approach for a positive learning environment. Prosocial skills and expectations are taught through our school-wide norms and motto 'Woodbine Wildcats R.O.A.R.' (Respect self and other, Offer kindness, Are always safe, and Resolve Problems). Additionally, Woodbine is invested to provide our students with 21st Century Learning opportunities and access. To that end, Woodbine has install SMART Boards in many of our classrooms, currently offer school-wide iReady subscription for Math and ELA to provide differentiated instruction, Lexia learning for all EL students and also has a chromebooks for each student (1:1). With these programs and more in place, Woodbine aims for students to thrive both in academics and social-emotionally.

We are proud of our students and their families for their dedication to education. The diversity of Woodbine's enrollment and community makes us a culturally rich learning environment for all students. Family activities are scheduled frequently to foster a strong parent/school relationship. Woodbine uses Class Dojo, school website, and school facebook page in addition emails and phone calls home to communicate with the community. ELAC and School Site Council meetings are held monthly. Our Student Support Center supports families helping with attendance, clothing, and referrals to community resources. Students also have opportunities for a variety of enrichment activities. ASES provides after school care, homework assistance, and extended learning opportunities including sports, MWLA, Cypher Hip-hop Dance, and the arts. Teachers provide tutoring for as

To that end, the district has crafted a high quality professional learning program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Mathematics, Science, Physical Education and Visual and Performing Arts. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our Local Control Accountability Plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design. Professional learning opportunities are offered during school hours and outside of contracted hours. ## School Facility Conditions and Planned Improvements

Woodbine Elementary School, built in 1953, received Facility Inspection Tool (FIT) overall repair rating score of “good” from its most recent facility inspection in September 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district’s 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district’s wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics.
