Good Morning SCUSD Board Members,

I am the mother of a high school student here in SCUSD, and I am writing to you today to express my concern and frustration with the continued COVID-related policies and procedures in place that appear to have no off-ramp in sight.

After this past weekend's Super Bowl game at SoFi stadium with 80,000+ people- nearly all unmasked and not socially distanced (including one of the board members of the CTA itself, and many other government leaders and celebrities), how can anyone in good conscious continue to promote and enforce masking of our children in schools, especially outdoors like SCUSD is? The harm that is being caused to their development and growth is far greater than any small benefit they bring - which even top health and medical organizations are recognizing and acknowledging. How can our children learn to speak and read, when they can't see others faces sounding out words and letters? How can our children learn empathy and pick up on facial cues with others when they can only see half their face? You put a lot of time and energy into supporting the mental health and "Social Emotional Learning" of our children, well I and many other parents believe the best thing you can do to improve those areas is to make masks optional and let them have a return to normalcy with their campus activities, extracurriculars, events and dances and such.

At this point, every adult has had nearly a year to get vaccinated if they so choose to. At this point, all school aged children have also been able to get vaccinated if their parents so chose to. At this point, there are an apparent abundance of N95's and KN95's for anyone who wants one. At this point, I would hope most understand the role of a healthy diet and exercise as well in the mitigation of COVID (considering the biggest risk factors are obesity, diabetes, and heart disease)....so now the time has come to get back to **real** normal and make vaccination and mask-wearing a choice left to us parents.

As this Omicron surge has affected plenty of vaccinated and boosted students and staff right along with those who are vax-free, how can you in good conscious continue with your own mandate for vaccination for COVID in order to attend in-person school? If anyone thinks "normal" will return once enough people are vaccinated (as your own social media posts continually try to claim "Hang out with your friends again! Get vaccinated!"), I would urge you to look at your own dashboard numbers of positive cases at schools that have the highest vaccination rates, like West Campus for example. How is it that a school that has a student vaccination rate of over 93% (as of 2/1/22), they still managed to have nearly 10% of their student population contract COVID in January? In comparison, Rosemont High School has just a 58% reported student vaccination rate and only had 10.5% positive cases? If the numbers are to be trusted in the dashboard, I would say that basic understanding of statistics is that vaccination made no real impact in case transmission rates after all. If what we were led to believe was true (that SCUSD continues to push - getting vaxxed will let us get back to "normal"), you would expect at least double the number of cases at Rosemont High, if not 3x's the amount since their vaccination rate is 35% less then West Campuses, but instead, the difference in case amounts was **not even 1 whole**

percentage point. This is all the proof I need to see to know this is not working the way you have been touting it!

My son is nearly failing his freshmen year as-is. The stress and uncertainty of not knowing if he'll be able to still attend school in-person should the PBE allowance be removed in the future is greatly affecting his education and well-being. He wants to be with his friends, and in the special programs and clubs he's in (that we moved to this area for in the first place!), but if push comes to shove and he gets forced into Independent Study over his vaccination status at some point, I will pull him with a quickness and move to another area where inperson learning is open for all if I have to. If you put a survey out to the parents who haven't submitted any info yet for an exemption or vax status, I'm sure you'll find I'm not the only one who feels this way.


My son has naturally-acquired immunity to COVID now, and his natural immunity should not be ignored and should be treated the same as those who've been vaccinated. Ironically, he caught COVID from his vaccinated friends! I'm not even mad that he got it from them, I knew it was bound to happen eventually as illness is a necessary and important part of growing up and building an immune system, and COVID will always be around and something we need to learn to live with. His illness was no different or worse than any other prior cold or flu he had pre-covid in fact. We treated him the same way we had any other illness - with immune-supporting healthy foods and vitamins, plenty of fresh air, fluids, rest and some time out in the sun everyday for Vit. D. What I am mad about is the fact that because he is not vaccinated, he is treated differently than those who've gotten the shot, even though his symptoms were less severe than many of his vaccinated peers! His natural immunity should be recognized and treated as if he were vaccinated. More and more studies are showing that natural immunity in children especially is robust and long lasting* - even longer than most of the shots in adults! Now we have hundreds, if not thousands of students and staff that have naturally-acquired immunity too. How can you continue to ignore this fact? "Follow the science" right? Or does that just apply to the science that fits your agenda?

Our children have sacrificed and suffered enough. The time is now to restore normalcy, to remove all mandates and end this supposed "State of Emergency". Let parents decide what is best for our children and end your resolution till the State itself can figure out if their mandate will even come to fruition. No other districts in our county are imposing a vaccination mandate at this time, and most don't require outdoor masking either. Even LAUSD has delayed theirs till the fall. Enough is enough, and parents like myself are fed up with the fear-mongering, the inconsistencies from school site to school site, the hypocrisy of our "leaders", and are ready to get on with our lives. Our least vulnerable population (children) should not be the most restricted. "Put children first" as your slogan states, and return their normalcy now.

	Over the past few months you have been talking about budget cuts and layoffs. As a parent, I'd like to address why teachers should not be a part of this discussion.
	First, teachers are the life-line for our students during this COVID season of highs and lows. They are our first responders. They are our eyes and ears on the ground with our children since we are not able to be on campus. Parents are relying on our teachers to love and care for our children during a global pandemic as well as address learning loss!
	Second, attendance and enrollment are not reliable during a global pandemic and shouldn't be the primary indicator of budget allocations at this time. Parents who pulled children from public school to private school are eager to come back to public school IF they see that our schools are ready and thriving. Laying off teachers sends a terrible message to parents who are on the fence about enrolling their children back into the public school system. Additionally, many families, such as my own, who are fully vaccinated, still contracted COVID. We have missed more school days than we ever anticipated. Our absent days are not dictated by our lifestyle or lack of parenting. Factors outside of our control (COVID) struck due to this global pandemic. I am one of thousands of families who have or are experiencing the same things and this must be taken into consideration. Attendance is not a good measurement to use to allocate funds or budget cuts at this time. It is not equitable to use metric systems in a global pandemic that was made in a prepandemic world.
