#### **RESOLUTION NO. 2731**

Resolution Authorizing the Adoption of a 403(b) and 457(b) Compliance Program and MidAmerica/Zuk Financial Services as Third Party Administrator

**WHEREAS**, the Governing Board of the Sacramento City Unified School District ("District"), designated as a governmental employer as defined in the Internal Revenue Code as amended, desires to implement the Mid America 403(b) and 457(b) Compliance Program; and

WHEREAS, the Governing Board has been made aware that the Internal Revenue Service has amended the 403(b) and 457(b) Tax Code to include requirements to engage in the audit of 403(b) and 457(b) Plans, the Board authorizes the Superintendent or designee to develop appropriate 403(b) and 457(b) plan documents and procedures to conduct a compliance review, followed by an ongoing compliance initiative, and to install necessary controls to ensure that the 403(b) and 457(b) Plans are operated in conformance with Internal Revenue Codes and related regulations as currently stated, and as amended in the future; and is further authorized to act on the Board's behalf with respect to the Plans.

**NOW, THEREFORE, BE IT RESOLVED,** that this Resolution is hereby adopted, approved, and supersedes and replaces any and all prior Resolutions and Plans of the District, authorizing Mid America as the third party administrator and compliance provider of the 403(b) and 457(b) Plans for the District.
