A13-00100 The David and Lucile Packard Foundation	1/23/13– 10/15/13: Implement Summer of Service 4 (SOS4) Learning Project at nine middle schools. The SOS4 project will enroll approximately 1,000 incoming 7th and 8th grade students at nine middle schools that currently have after school programs. Using a youth development and social justice framework, the SOS4 project will involve students in the planning and implementation of school and community improvement projects tailored to their communities. Projects will examine environmental and health related problems faced by disadvantaged communities (e.g., lack of green space, obesity, lack of fresh fruits and vegetables, safe spaces for outdoor physical activity) and will show youth how to be agents of change who can transform their schools and community. The service learning projects will incorporate literacy and math development, and will include connections to the out-of-doors, healthy eating, healthy lifestyles, and physical activity.	\$110,000 No Match
