**RESOLUTION NO. 2729**

**RESOLUTION CONFIRMING CERTIFICATION OF ELECTION RESULTS**

**WHEREAS**, Elections Code 15400 requires the governing board of a school district to declare results of each election under its jurisdiction; and

**WHEREAS**, Education Code section 15274 requires an equivalent declaration or certification regarding Proposition 39 bonds.

**NOW, THEREFORE, BE IT RESOLVED** that the Sacramento City Unified School District Board of Education (“Board”) certifies and declares as follows regarding the November 6 General Election:

1. Pursuant to the Registrar of Voters of Sacramento County and the Certificate of Facts submitted to the Board of Education of the Sacramento City Unified School District (“District”), and in compliance with Elections Code 15400, Christina Pritchett for Trustee Area 3 and Patrick Kennedy for Trustee Area 7 were elected by a majority vote of the registered voters voting in their respective trustee areas and bond measures Q and R (the “Bond Measures”) were approved by more than 55% of the registered voters of the District who voted at the General Election. Pursuant to Education Code sections 5326 and 5328, incumbent Board members Diana Rodriguez representing Trustee Area 5 and Gustavo Arroyo representing Trustee Area 4, having been nominated and there being no further nominations for the General Election, by operation of law, are deemed appointed, and so certified and declared as appointed by the Board, and shall be seated as if elected at a District election.

2. Pursuant to the Registrar of Voters of Sacramento County and the Certificate of Facts submitted to the Board of Education of the Sacramento City Unified School District (“District”), and in compliance with Education Code 15274, the Board certifies to the Board of Supervisors of the County of Sacramento, and so incorporates into its minutes this resolution, that the Bond Measures were duly passed, as set forth in section 1 above, in compliance with section 18(b) of Article XVI of the California Constitution and that all proceedings relating to the election and approval of the Bond Measures were duly had and conducted.

3. In compliance with Education Code 15274, a copy of the resolution shall be sent to the Board of Supervisors of the County of Sacramento.

4. This resolution shall take effect immediately upon adoption.
