

6.0 AGENDA ADOPTION

President Kennedy requested for a motion to approve the agenda. Second Vice President Pritchett made the motion and Member Cuneo seconded the motion. The Board voted unanimously to adopt the agenda.

7.0 SPECIAL PRESENTATION

7.1 Mr. Joseph Stymeist presented the SCUSD High School Robotics Competition Teams with Certificates of Appreciation and thanked the Coaches, Team Captains, and Students for all their hard work and dedication. Mr. Stymeist announced Kennedy High School teacher, Mr. Robert Greene, recently was the recipient of the coveted Woodie Flowers Award for his outstanding job as a mentor in the engineering field. Team Captain of Kennedy High School Robotics, Danielle Quan, shared the benefits of her time spent with the Robotics Team. She noted during her tenure as team captain, she learned lifelong leadership skills and was given the opportunity to expand her love of engineering. 9.1 A Public Hearing on Charter School Petition for
New Joseph Bonnheim (NJB) Community Charter School was heard.
Dr. Teresa Cummings introduced the lead petitioners, Lisa Romero, Art Aleman, and Michael
Madden to present on the New Joseph Bonnheim Community Charter School. A PowerPoint
Presentation was given and a discussion among Board members and the lead petitioners
followed.

Public Comments

- Alex Visaya, Community Advocate, stated NJB Charter is a great idea. Mr. Visaya thanked the Board and urged their support of the proposed Charter School.
- Jonathan Tran of Hmong Innovative Politics has worked with many families that were

- affected by school closures in 2013. The voices of students, parents, teachers, and community members should be a part of the decision making.
- Tim Haas, Director of Club Z Tutoring expressed his support for NJB Community Charter.
- Chandra Roughton, educator, supports the agriculture based NJB Community Charter petition.
- Shannon Zavala, teacher at Bowling Green Elementary stated her support of the NJB Community Charter.
- Maria Haro- Sullivan, District Advisory Council (DAC) President, stated her support of the NJB Community Charter.
- Manuel Pickett stated his support of the NJB Community Charter.
- Grace Trujillo stated her support of the NJB Community Charter.
- Martin Dominguez, a parent at Peter Burnett Elementary School stated his support of the NJB Community Charter.
- Cheryl Ewing, a parent at Alice Birney Elementary School stated her support of the NJB Community Charter.

Board Member Comments

- Member Arroyo thanked the parents for leading the petition for the New Joseph Bonnheim Community Charter. Member Arroyo recognizes Sacramento as part of the Central Valley that contributes to a billion dollar agricultural industry. Member Arroyo stated the NJB model could provide for workforce development and provides several layers of knowledge and is a great potential outlet to partner with industry leaders within agriculture.
- Second Vice President Pritchett stated the project was, "parent engagement at its finest." However, Member Pritchett also stated concern regarding startup costs and the potential risk to the District's budget if the NJB Community Charter did not meet the enrollment numbers to support the average daily attendance (ADA) funding necessary to operate the Charter School.
- Member Rodriguez stated she was compelled by the potential of the NJB Community Charter but wanted a more complete analysis from the petitioners about how they would bridge the gap in funding to reduce financial risk to the District.
- Member Cuneo stated his concerns of the fiscal solvency of the NJB Community Charter and high financial risk to the District. Member Cuneo also stated his concern of the absence of public community partnerships. Member Cuneo thanked the petitioners, teachers, students and parents for the time and effort put forth in the project.
- Member Hansen thanked the parents for bringing forward a parent-centered proposal for the NJB Community Charter and stated it merits support. Member Hansen stated his concerns of fiscal responsibility. He requested projections of what the student demographics would be and asked how many of the anticipated students will come from outside of the

district.

11.1 Stephan Brown presented on the Revised Board Policy 5144, Positive School Climate Conference/ First Reading

Public Comment

- Carl Pinkston of the Black Parallel School Board stated his support of the BP 5144 revisions.
- Martin Ramirez stated his support of the BP 5144 revisions.
- Brit Irby, representative of the Restorative Justice Task Force, Coordinator of Youth Engagement Services, and parent within the district stated her support of the revisions to BP 5144. Ms. Irby stated there are disproportionate suspensions of African American and

Latino males and stated the revisions are what the students need.

- Jonathan Tran, Program Manager of the Southeast Asian Resource Action Center stated his support of the BP 5144 revisions.
- Amoryon Bates of Kennedy High School student and member of the Men's Leadership Academy stated his support of the BP 5144 revisions.
- Malik Camara, Kennedy High School student and member of the Men's Leadership Academy, stated his support of the BP 5144 revisions and thanked the Board for listening to students like himself that have been negatively affected by the original BP 5144.
- The Honorable Stacy Boulware-Eurie, Presiding Judge of the Sacramento Juvenile Court, stated when students act out, it is an opportunity to steer them back on the right track. Judge Boulware-Eurie also stated when children are not in school, they tend to engage in behavior that leads them to the Juvenile Court system and policies similar to the original BP 5144 disproportionately affect Foster Care students and students with disabilities. Judge Boulware-Eurie thanked the Board for providing students greater opportunities to move forward.
- Terrence Gladney, Sacramento Council PTA President, stated his support of the BP 5144 revisions.
- Elizabeth Esparza stated her support of the BP 5144 revisions.
- Angie Sutherland stated her support of the BP 5144 revisions.

Vice President Woo also thanked Darlene Anderson for her discussion around looking at data and Mr. Pinkston for his comments regarding the Whole Child Policy within Resolution 2789. Vice President Woo asked how the district will measure success in the reduction of suspensions received.
