Comment:	It is so disheartening to realize that the SCTA essentially gave up on the students this school year. My children are in 1st and 3rd grade and have been utterly failed by the leaders in our District. The District has been trying for weeks to negotiate the MOU to reflect current public health guidelines. In adopting a 6-foot distancing requirement, the MOU was outdated from the outset. The SCTA has made no good faith effort to renegotiate the MOU to reflect the current 3-foot spacing recommendation. The reasoning I've been told is essentially, "it was so hard to negotiate the initial MOU, we couldn't possibly return to the table."
	You know what is hard? Seeing my children lose interest in school. Knowing that the education gap between the haves and have-nots has widened. Knowing that there are many children who have simply fallen through the cracks. Knowing that cases of depression, anxiety, anhedonia, and suicide among children have been increasing this past year.
