You are hereby notified of the following changes, clarifications, or modifications to the original Request for Qualifications (RFQ). This Addendum shall supersede the original RFQ documents, and shall take precedence over anything to the contrary therein. All Addenda shall be acknowledged in the response. All other conditions remain unchanged.

Submittal Requirements

- A. The District has increased the page limit for submittals. Submittals shall be no more than thirty (30) single-sided pages or fifteen (15) double-sided pages in length. This page limitation excludes front/back covers, divider sheets/tabs, tables of contents and appendices.
- B. Appendices may include fee proposals and objections/proposed changes to the form of agreement.

Form of Agreement

A. Exhibit F of the Form of Agreement has been updated, due to a change in requirements after the District's Board of Education passed <u>Resolution No. 3233</u>. CM firms will be required to execute the new Vaccination Certification upon award of a contract. A copy of the certification form is attached.

Exemptions are to be filed with the individual's employer: District staff and students with the District and contractors with their employers - the CM firm in this case.
