Local Control Funding Formula (LCFF)


Lub Xya Hli tim 1, 2013 Governor Brown tau xee npe rau tsab cai keeb kwm tsev kawm ntawv pob nyiaj txiag: the Local Control Funding Formula (LCFF).

“Hnub no, kuv tau kos npe rau daim ntawv no uas yog ib qhov kev hloov pauv loj tseeb tshaj plaws,” Governor Brown hais li. “Peb coj tseem fwv tuaj kom ze rau cov neeg, rau hauv chav kawm uas yog cov kev txiav txim siab tiag tiag thiab xa cov nyiaj mus kiag rau qhov kev tu ncua thiab qhov kev kawm yog qhov zoo tshaj. Qhov no yog ib hnub zoo rau California, yog ib hnub uas zoo rau cov menuam kawm ntawv thiab rau peb lub neej pem suab.”

LCFF Txhais Tau Licas?

- Kom paub txog tias SCUSD tau txais li ntawm 65% ntawm pob nyiaj tau los ntawm lub Xeev California nyob rau hauv LCFF
- Nrog rau LCFF, cov hauv paus tsev kawm ntawv xaiv tau seb yuav muab pob nyiaj no faib licas raws li cov tub/ntxhais kawm ntawv qhov kev tu ncuia
- Tau muab nyiaj ntxiv rau cov hauv paus tsev kawm ntawv los qhia cov tub/ntxhais kawm ntawv uas muaj kev tu ncuia ntau tshaj

Peb (3) Theem ntawm Pob Nyiaj

- LCFF Base Funding – txhua lub hauv paus tsev kawm ntawv tau txais ib qho nyiaj rau “ib tug menuam,” raws li seb tuaj kawm los tsis tuaj
- LCFF Supplemental Funds – faib tso raws li tus leb qhia tias cov menuam kawm ntawv uas tau nyiaj hli tsawg, cov menuam tseem kawm ntawv Askiv, cov menuam nyob tsis muaj vag muaj tse thiab cov menuam nyob nrog niam qhuav txiv qhuav
- LCFF Concentration Grant – Ib qho nyiaj ntxiv rau cov hauv paus tsev kawm ntawv uas muaj cov tub/ntxhais kawm ntawv ntau tshaj 55% uas tau noj sus dawb/txo tus nqi noj zaub mov



Qhov txawv rau peb lub hauv paus tsev kawm ntawv no yog licas?

- Yooj yim ntau dua rau kev muab cov nyiaj txiag tso kom zoo rau cov kev pabcuam
- Pom tseeb dua thiab saib xyuas kom ncaj rau lub zej zos thiab lub xeev
- Qhov xav tau loj tshaj rau kev sib txuas lus txog cov homphiaj, cov kev nqes tes thiab cov kev pabcuam rau cov tub/ntxhais kawm ntawv

Local Control & Accountability Plan (LCAP)

- Txoj kev npaj (plan) uas ib lub hauv paus tsev kawm ntawv tsim, yuav piav qhia txog cov homphiaj, thiab qhia meej cov kev nqes tes thiab cov kev pabcuam kom ua tau raws li cov hom phiaj.
- Kev siv nyiaj tawm yuav qhia rau hauv LCAP, qhia kom meej meej txog pob nyiaj siv los mus nqis tes pab
- Cov muaj tshwm sim tau qhia los ntawm cov ntaub ntawv rov muab los saib thiab kev siv nyiaj tawm yog li cas kiag.



Accountability

- Tim khawv ntawm kev pab rau ib lub ntawm thawj yim (8) qhov uas lub xeev xam pom tias tseem ceeb.
- Ntxiv lossis kho cov kev pabcuam rau cov tub/ntxhais kawm ntawv uas yog:
 - Tau Nyiaj Hli Tsawg
 - Tseem kawm ntawv Askiv (English Learners)
 - Tsis muaj vag muaj tse thiab nyob nrog niam qhuav txiv qhuav
- Qhov uas tau sib tuav tswv yim nrog cov muaj feem (stakeholders) raws li lub hauv paus tsev kawm ntawv tsim thiab kho txoj kev npaj (plan).



Qhov uas pab tau ntawm kev koomtes rau xyoo tas los yog dabtsi?

- Txoj kev npaj (plan) yog tsim nrog kev pab tawm tswv yim los ntawm lub zej zos.
- Tshaj 2,000 tus neeg tau teb kev soj ntsuam hauv online, lossis tau teb raws ib a qhov PEV.
- Kev koomtes hauv lub zej zos tau pab kho cov hom phiaj thiab kev nqes tes ntawm LCAP.






Tsev Kawm Ntawv Them Nyiaj
