# Special Education Assessments

---

- CDE Complaint

- A complaint was filed with the California Department of Education (CDE) on November 20, 2020 alleging a violation of the District's obligation to conduct special education assessments within 60 days of receiving signed assessment plans.
  - Two additional complaints were filed with CDE on January 6, 2021 and January 22, 2021 alleging a violation of the District's obligation to timely conduct special education assessments.

# SELPA Local Plan Requirements

---

The Individuals with Disabilities Education Act (IDEA) and related federal regulations, require each special education Local Plan area (SELPA) to ensure a continuum of program options are available to meet the needs of students with disabilities for special education and related services.

The California Department of Education (CDE) has established guidelines for the coordinated development and submission. The required Local Plan components include

- Section A: Contacts and Certifications
- Section B: Governance and Administration
- Section D: Annual Budget Plan
- Section E: Annual Service Plan
- Required Attachments I–VII.

**Beginning July 1, 2020, all SELPAs are required to submit a Local Plan, using CDE-adopted templates. (CA Ed Code 56122)**

- **Standard Format**
- **Increase Parental Involvement**
- **Improve Transparency**
- **Provide Effective Staff Development Activities**
