The District continues to review this Article to ensure that it incorporates all changes agreed upon in the Tentative Agreements between the District and SCTA reached since the contract was last updated in 2011. The District also has an interest in working with SCTA to ensure that position titles are correct and consistent with current position titles.]

ARTICLE 17 - CLASS SIZE

17.a The District's goal is that all class size maximums will be met by the end of the first week of school with students in order to enhance the educational process. Schools unable to meet maximums by this time are not subject to any grievances. School administrators must communicate the reason(s) to their supervisors for inability to meet maximums.

The parties may agree to discuss other issues.

17.1 <u>Elementary Class Size Limitations</u>

- 17.1.1 **[District is restoring to status quo except as noted]** At the kindergarten level, the maximum class size shall not exceed twenty-four (24) students per teacher. <u>[Need to discuss TK]</u>, so long as LCFF Class Size Grade Span Adjustment (GSA) funds are in effect. If LCFF Class Size Grade Span Adjustment (GSA) funds are not continued, the class size maximum shall not exceed twenty-nine (29).
- 17.1.2 [District is restoring to existing language except as noted] At grades 1- 3, the maximum class size shall not exceed twenty-four (24) students per teacher, so long as LCFF Class Size Grade Span Adjustment (GSA) funds are in effect. If LCFF Class Size Grade Span Adjustment (GSA) funds are not continued, the class size maximum shall not exceed twenty-eight (28).
- 17.1.3 At grades 4-6, the maximum class size shall not exceed thirty-three (33) students per teacher. [District is restoring existing language]
- 17.1.4 Instrumental music teachers will not be included in determining the staffing ratio in the elementary school.
- 17.1.5 The maximums established in Section 17.1 of this Article may be exceeded by mutual agreement between the site administrator and the affected teacher. [District is restoring existing language]
- 17.1.6 The District shall have 15 <u>school</u> days at the beginning of each school year to adjust classes to meet the maximums established in 17.1.1 through 17.1.3. Thereafter, maximums in any class may be exceeded by no more than three (3) students and only for a cumulative total of five (5) school days during any school year as required to

meet student needs, except in those classrooms where the mandates set forth by the state do not allow for larger class sizes. In those instances where a class size exceeds the maximum, certificated staff shall be paid ninety dollars (\$90) per day for every day the class exceeds the maximum.

17.1.7 When two or more classes of the same grade level(s) are housed at the same school site, the enrollment difference between the smallest and largest classes shall not exceed <u>three (3) five except by mutual agreement of the site administrator and the teachers involved.</u> [District agrees]

17.2 Special Subject Teachers

- 17.2.1 Special subject teachers shall provide release preparation time for no more than seventeen (17) qualifying teachers per week excluding him or herself. Qualifying teachers means grades 1 through 6 classroom teachers, including special day class teachers (which shall include aide support). [District is restoring to existing language]
- 17.2.2 The maximum teacher load <u>for special subject teachers</u> shall not exceed 190 students per day. [District agrees]

17.3 Secondary Class Staffing Formula

17.3.1 7th and 8th Grades

One (1) teacher per thirty-one (31) students enrolled; which shall be computed on third-month projected enrollment. add oOne (1) teacher shall be added for all fractional remainders over 0.50. [District is restoring to existing language, except as noted]

17.3.2 **9th, 10th, 11th, and 12th Grades**

One (1) teacher per thirty-two (32) students enrolled; which shall be computed on third-month projected enrollment. add oOne (1) teacher shall be added for all fractional remainders over 0.50. [District is restoring to existing language, except as noted]

17.3.3 Secondary staffing shall be based upon third-month projections. [District agrees]

- 17.3.4 The student/counselor* workload will be one (1) full-time counselor for each 375 students enrolled, based upon the projected third-month enrollment. Additional counseling service shall be provided on the basis of one (1) counseling hour for each sixty (60) students in excess of the 375/1 ratio, also based on the third-month projected enrollment. No more than fifty-nine (59) additional students shall be assigned to the total counseling staff at a school before additional counseling hours shall be-are provided, except by mutual agreement between the site administrator and the counselor(s). [District agrees]
- 17.3.5 The student/counselor* workload in continuation high schools, independent study school (Capital City), <u>Accelerated Academy</u>, and the opportunity school will be one (1) full-time counselor for each 150 students enrolled, based upon the third-month projected enrollment. [District agrees to SCTA addition of Cap City and proposes adding Accelerated Academy]

17.4 <u>Secondary Class Size Limitations (Overages)</u>

The District will share ELDL class size information with SCTA.

17.5 In addition to the foregoing limitations, students shall not be regularly placed in a classroom in larger numbers than the capacity of the teaching facilities or basic work stations available where a student normally spends the majority of the class time performing the operational functions necessary to meet performance objectives and goals of the course.

17.6 Special Education Class/Caseload Size Maximums

17.6.1 Based on each students' IEP, the District will provide a continuum of services for special education students receiving special education services that will meet the educational requirements of students with special needs students while providing those services in the Least Restrictive Environment in accordance with state and federal law. The class size maximums for special education shall be as specified by the California State Legislature and/or Department of Education state and federal law requirements, except for the following limitations agreed upon by the parties. Students with special needs will be provided with appropriate supports as informed by students' IEPs and as outlined below:---- [District agrees]
