Home Hospital Instruction Updates and Changes Office Manager Meeting

"A student with a temporary disability, which makes school attendance in regular day classes or alternative education program in which the student is enrolled impossible or inadvisable, shall receive individual instruction in the student's home or in a hospital or other residential health facility, excluding state hospitals. The goal of home or hospital instruction should be maintenance of the pupil's former level of performance while recovering." -CA Ed Code 48206.3/SCUSD BP 6183

Service Delivery:

General Education Students

- Home Hospital Instruction (HHI) in the home, hospital setting, or virtually-if deemed medically necessary for up to 5 hours of instruction a week.
- For Medical Independent Study (MIS) needs, students will be enrolled at Capital City and follow IS guidelines.

- 2. An addendum meeting will be scheduled to discuss HHI placement and changes to the student's offer of FAPE.

Changes & Updates

Old:

- HHI students were disenrolled from their SOR
- Student Attendance was completed manually on a spreadsheet
- Students required a minimum of 6 weeks approval by a doctor


New:

- Students will remain at their SOR
- Student attendance will be entered into Infinite Campus using codes
- > Students can now qualify for 4-8 weeks depending on approved doctors orders

New Process beginning 2023-24

- Students will remain at their current school of enrollment.
 - The general education enrollment will end
 - A new HH enrollment will be created (with a different Attendance Funding Category: 18).
 - Students will return to general education enrollment (10: Regular Day) when they are able (End HH enrollment; create new enrollment)
- 3. A new flag named "Home Hospital Instruction" will be added to identify students while on the HHI program.(HHS Case Manager)
- New attendance codes will be created
 - HHC Home Hospital Complete
 - HHI Home Hospital Incomplete
- 4. Students on HHI will remain scheduled into their regular courses, if able to continue normal course workload.
- 5. A HH teacher will be assigned to the needed sites/sections of courses to monitor course work.
