Recommendation: To conduct a Public Hearing on the SELPA's Amended Annual Service Delivery Plan and the Annual Budget Plan.

Background/Rationale:

- The SCUSD SELPA Local Plan requires a service plan and budget be developed and updated annually.
- The Annual Service Plan describes the full continuum of services provided by the district for students, birth to 22 years of age, including students with low incidence disabilities.
- The Budget Plan describes those funds received in accordance with EC 56836 and the expenditures of those funds.
- The California Department of Education returned the 2010-2011 Annual Service Plans to SELPAs to be amended to include a provision of special education services for eligible students residing in county jails.
- This Board Approved amended plan will serve to comply with both 2010-2011 and 2011-2012 reporting requirements.

Financial Considerations:

The department currently has central special education staff to serve sites when caseloads go above contractual limit and to serve students in charter schools that are a part of our SELPA. This staff would be able to accommodate a short-term assignment if it occurs at the county jail. Therefore, there are no additional resources needed.

I. Overview/History:

Assembly Bill (AB) 602, Chapter 654, Statutes of 1997, requires the Special Education Local Plan Area (SELPA) to submit an Annual Budget and Service Plan that is adopted at a public hearing. As required in Education Code section (EC) 56205, these plans must identify expected expenditures, including a description of the services provided and their physical location. The plan must also demonstrate that all individuals with exceptional needs have access to services and instruction appropriate to meet their needs as specified in their Individualized Education Program (IEP). The 2010-2011 Annual Service and Budget Plan was adopted by this Board on March 17, 2011. In August, 2011, California Department of Education notified each SELPA that they were required to specify the provision of services for eligible students residing in the county jail. On September 23rd, CDE issued an advisory with guidelines for SELPAs to amend their current 2010-2011 Annual Service Plan to include this additional provision of service and options for proving that the plan has been amended.

There are no additional budget considerations for this amendment. Current resources will be diverted to this purpose if the SELPA acquires an eligible student residing in the county jail whose parent resides within our district boundaries.

Provide an equitable special education program which is aligned to the District's Strategic Plan, appropriate to meet the needs of our students and is compliant with the law.

V. Major Initiatives

The Sacramento City Unified School district SELPA continues to provide a full continuum of services to meet the needs of students with special needs as specified in their Individualized Education Program (IEP).

One of the primary focuses of the SELPA is to provide a compliant and equitable system of distributing funds to provide services to students with special needs. This is realized operationally by abiding to reporting timelines and amendments as they are directed by CDE. 
