## 1.0 OPEN SESSION / CALL TO ORDER / ROLL CALL

Allotted Time

The meeting was called to order at 5:05 p.m. by First Vice President Kennedy. Members Present: Bell, Cuneo, Kennedy, Rodriguez, Terry, Woo and Student Member Fong. Absent was President Arroyo.

Member Terry requested that the Board recess in to Closed Session to discuss items on the Consent Agenda. Member Terry asked that Closed Session be moved prior to the Consent Agenda. First Vice President Kennedy polled the board and this was agreed to.

# 2.0 STRATEGIC PLAN AND OTHER INITIATIVES

2.1 AB1200 disclosure of costs of agreement with Service Employees International Union, Local 1021 (SEIU) pursuant to Government Code Section 3547.5 and Approval of tentative agreement with Service Employees International Union, Local 1021 (SEIU) for three Furlough days for the 2011-12 school year and the Tentative Agreement to Extend the Contract for Three Years (Robert R. Garcia)

Action

Robert Garcia presented the tentative agreement with SEIU Local 1021 to the Board for approval.

Member Terry made a motion to approve the tentative agreement, seconded by Second Vice President Bell. The motion carried 6-0 with Student Member Fong abstaining and President Arroyo absent.

2.2 AB1200 disclosure of costs of agreement with Teamsters Union, Local 150 (Teamsters) pursuant to Government Code Section 3547.5 and approval of tentative agreement With Teamsters Union, Local 150 (Teamsters) for three Furlough days for the 2011-12 school year and the Tentative Agreement to Extend the Contract for Three Years (Robert R. Garcia)

Action

Robert Garcia presented the tentative agreement with Teamsters Local 150 to the Board for approval.

Member Terry made a motion to approve the tentative agreement, seconded by Member Woo. The motion carried 6-0 with Student Member Fong abstaining and President Arroyo absent.

Scott Smith, President of SCTA commented on item 4.1b which was going to be discussed in closed session.
